Assam logs 11 new COVID-19 cases, tally at 7,24,099

GUWAHATI: Assam on Saturday registered a decrease in fresh COVID-19 cases with 11 more people testing positive for the infection, seven less than the previous day, the National Health Mission (NHM) said

During the day, the state tested 2,358 samples for COVID-19, the NHM bul-

Assam had recorded 18 cases against the testing of 3,763 samples on Fri-

day. One person had succumbed to the infection on Friday while no fresh fatality was recorded dur-

ing the day. Kamrup Metropolitan district, which primarily comprises Guwahati city, reported four fresh cases, followed by two each in

Hailakandi and Jorhat, and one in Barpeta. The NHM said that the number of patients who recovered from the disease decreased to 41 on Saturday from 73 people

on the previous day. In Assam, 7,15,881 COVID-19 patients have so far recovered from COVID-19. The total number of deaths of COVID-19 in-

fected people stands at 7,985, including 1,347 with co-morbidities, the bulletin said. Currently, the state has a total of 233 active coronavirus

Ukraine crisis: First Air India evacuation flight with 219 citizens lands in Mumbai



MUMBAI, FEBRUARY 26

The first Air India flight carrying 219 Indian evacuees from Ukraine landed at the Mumbai airport from Bucharest, Romania, on Saturday evening, ATC sources said.

Operated with a Boeing 787 Dreamliner plane, Air India flight AI-

1944 touched down the runway at Chhatrapati Shivaji Maharaj International Airport (CSMIA) here at 7.50 pm, they said.

Union Minister Piyush Goyal was at the airport to receive the Indian nareturning from war-hit Ukraine on their arrival.

The Air India flight had left from Mumbai for Bucharest at 3.38 am Saturday and landed there at around 10.45 am (Indian Standard Time). It departed for Mumbai at 1.55 pm (IST). The Ukrainian airspace has been closed for civil aircraft operations since the morning of February 24 and therefore, the evacuation flights are operating out of Bucharest and Budapest.

Indian nationals who reached the Ukraine-Romania border by road have been taken to Bucharest by Indian government officials so that they can be evacuated in the Air India flights.

Around 16,000 Indians, mainly students, were stranded in Ukraine, Foreign Secretary Harsh Vardhan Shringla had said on February 24. The distance between Kyiv and the Romanian border checkpoint is approximately 600 km and it takes anywhere between eight hours to 11 hours to cover it by road.

The Indian embassy in Ukraine on Friday said it was working to establish evacuation routes from Romania and Hungary. External Affairs Minister S Jaishankar had earlier in the day said on Twitter that AI1944 with "219 Indian nationals has taken off from Romania". "Regarding evacuation of Indian nationals from Ukraine, we are making progress. Our teams are working on the ground round the clock. I am personally monitoring," he added.

198 killed, over 1,000 injured in Russian invasion: Ukraine Minister

AGENCY KYIV, FEBRUARY 26

The Ukrainian Health Minister says that 198 people have been killed and more than 1,000 others have been wounded in the Russian of-

Health Minister Viktor Lyashko said on Saturday that there were three children among those killed. His statement made it unclear whether the casualties included both military and civilians.

He said another 1,115 people, including 33 children, were wounded in the Russian invasion that began on Thursday with massive air and missile strikes and troops forging into Ukraine from the north, east and south.

Meanwhile, Russian forces pounded Ukrainian cities, including the capital Kyiv, with artillery and cruise missiles on Saturday for a third day running and Russia's Interfax news agency said they had captured the southeastern city of Melitopol.

Ukrainian officials were not immediately available to comment on the fate of Melitopol and Britain's armed forces minister James Heappey cast doubt on the report, saying the city of some 150,000 people was still in Ukrainian hands.

"All of Russia's day one objectives ... and even Melitopol, which the Russians are claiming to have taken but we can't see anything to substantiate that, are all still in Ukrainian hands," he told BBC radio.

Western intelligence sources say Russian forces encountered stronger Ukrainian resistance than they had expected and this was significantly slowing their advances since their invasion began on Thursday.

If the Interfax report about Melitopol, which cited Russia's defence ministry, is confirmed, it would be the first significant population centre the Russians have seized. At least 198 Ukrainians,

including three children, have been killed and 1,115 people wounded so far in Russia's invasion, Interfax quoted Ukraine's Health Ministry as saying. It was unclear whether the numbers comprised only civilian casu-

Kyiv's mayor Vitali Kl-itschko said 35 people, including two children, were wounded during overnight fighting in the city.

Klitschko said there was currently no major Russian military presence in Kyiv, although he added that saboteur groups were active. The system now working only as a shelter for city residents and trains have stopped running,

Cabinet allows up to 20 per cent **FDI in IPO-bound LIC: Sources**

NEW DELHI, FEBRUARY 26

The Union Cabinet on Saturday permitted up to 20 per cent foreign direct investment (FDI) under automatic route in IPO-bound LIC with an aim to facilitate disinvestment of the country's largest insurer, sources said.

The decision in this regard was taken by the Cabinet, chaired by Prime Minister

The government has approved listing of shares of LIC on the stock market through an IPO by part-sale of its stake in the insurer and raising fresh equity capital.

Foreign investors may be desirous of participating in the mega IPO. However, the existing FDI policy did not prescribe any specific provision for foreign investment in LIC, which is a statutory corporation established under the LIC Act, 1956.

Since as per the present FDI policy, the foreign inflows ceiling for public sector banks is 20 per cent under government approval route, it has been decided to allow foreign investment of up to 20 per cent for LIC and such other corporate bodies.

Further, in order to expedite the capital raising process, such FDI has been kept under the automatic route, as in the case of the rest of the insurance sector, one of the sources

Besides Iyer, Ravindra Jadeja blasted 45 off 18 balls as India chased down the target of 184 with 17 deliveries to spare and register their 11th straight win in the format. Sanju Samson also contributed 39 off 25 balls.

The Indian bowlers leaked runs in the last five overs but Rohit refused to put the blame on his bowling unit.

the-match Iyer for their batting perform-"Jaddu (Ravindra Jadeja) came and looked positive from ball one and Shreyas



NEW DELHI: Humpback whales have been removed from the threatened species list after a significant increase in numbers in the 60 years since they were first protected, but green groups warn populations could decline again as oceans

Study reveals differences in how humpback whales change tune The Australian environment minister, Sussan Ley said removing the humpback whale from the threatened species list was "a recognition of the success of the outstanding conservation efforts that are in place". International protections against whaling and domestic protections to preserve the species remain in place, Ley said The number of humpback whales in Australian

waters has grown from just 1.500 at the height of the commercial whaling industry to an estimated 40,000, Ley said. "Australia is a world leader in whale conservation, and we will continue to work through the International Whaling Commission to promote whale conservation and maintain the alobal moratorium on commercial whaling." she said. "Our removal of the humpback from the threatened species list is based on science and sends a clear signal about what can be achieved through coordinated action. It is a message of hope for the welfare of a number of species." Commercial whaling in the southern ocean in the 19th and early 20th century pushed many whale species, particularly the humpback and southern right, to the brink of extinction. More than 30,000 humpback whales were killed by whalers operating in Australia and New Zealand before local whaling

Alexia Wellbelove, a senior campaign manager for Humane Society International, said while whale numbers had shown a "remarkable recovery" in the 60 years they received worldwide protection, the decision to delist the marine mammals "may prove to be short-sighted in the face of looming climate

Make List Of 'Kauravas' In Congress: Rahul Gandhi To Party Leaders In Gujarat

Gandhi on Saturday asked his party leaders in Gujarat to prepare a list of "Kauravas" in the party, who just "sit in their AC offices, do nothing but talk and disturb others", adding that such people eventually cross over to the BJP.

He also hit out at the Modi government over the use of central agencies, saying it has "CBI, ED, media, police and goons", and said ultimately it is the truth that matters.

Alleging that Gujarat is suffering because of "BJP's politics", he said Congress has an opportunity to win the next Assembly polls in the state, but it fails to convey a clear vision to the people about what it intends to do after it comes to power.

Gandhi, who was in Gujarat as part of his day-long visit, was addressing the party leaders and office-bearers on the second day of the three-day Chintan Shivir, a brainstorming session, organised here by the state unit of the party to chalk out the strategy for the Assembly elections due in December

Before coming to the venue, he visited the Dwarkadhish temple dedicated to Lord Krishna, where he offered prayers

"They have CBI, ED, media, police, goons and new attire everyday. But those things don't matter at all. Gujarat teaches us that what matters is truth. Look at Gandhiji. Did he ever have the truth is always simple," he said.

"Congress workers must understand that they have already won the Gujarat Assembly election. You are just not accepting it. People of Gujarat are watching you with high hopes. The BJP has harmed the people of Gujarat more than it has harmed the Congress

Sharing a bold vision for the revival of Congress and to win the upcoming election here, Gandhi suggested getting rid of leaders who "sit in air-conditioned rooms and disturb others".

Editorial Blood on the hands

s missiles rain down on Ukrainian cities, the world is grappling with the key question of how World is grapping with the key queens to leave no napresident, Vladimir Putin, that threatens to leave no nation untouched. The United States of America, the United Kingdom and the European Union have all imposed a series of tough sanctions against Russia in response to the invasion of Ukraine that Kiev said had left at least 137 people dead by Friday morning. But more than any economic punishment from Washington, Brussels and London, it is Mr Putin s own actions that could undermine Moscow s long-term strategic interests while crippling an image he has carefully cultivated among ordinary Russians. Western sanctions, so far, focus on Russia s financial system, cutting its biggest banks off from accessing the European and American markets as well as dollars. The measures also include blocking Moscow s access to Western technology that is critical for modernizing the Russian military and aerospace industries.

These are not the first Ukraine-related sanctions that Moscow has faced. Since 2014, when Russia annexed Crimea, the US has targeted oligarchs and other individuals close to Mr Putin with economic restrictions. While those steps did dent the Russian economy, the hurt was not enough to change the Kremlin s calculus. The new sanctions imposed this week are much tougher and will rock Russia s economy. The rouble has already fallen by 20 per cent against the dollar since earlier this month. Reports suggest Russians are desperately converting their money into dollars at banks. It is unclear if that pain will make Mr Putin reconsider his plans. In the meantime, the world will witness spikes in the prices of energy because of Russia s dominance in the sector; and food, because of Ukraine s status as a leading exporter of wheat and corn. Inflation will rise.

But the most lasting impact of this crisis might be on Russia, global politics and on Mr Putin himself. Over the past two decades, he has built a domestic image of a calm, cold, calculating leader who brought stability to Russia. His recklessness in Ukraine demolishes that. The large protests against the invasion that have erupted across major Russian cities — despite the knowledge that participants will be arrested and blacklisted — show that for many, the fear of Mr Putin is beginning to crumble. The Russian president s actions have united Moscow s previously divided opponents like NATO and the EU. European leaders who were his allies, like the Czech Republic s president, Milo Zeman, and Hungary s prime minister, Viktor OrbÆn, are now openly condemning Mr Putin.

Will RSS do a rethink over Modi if he takes hit in UP?

he February-March 2022 Assembly elections in five states Uttar Pradesh, Punjab, Ut-

tarakhand, Goa and Manipur seem different from any other state polls since Prime Minister Narendra Modi took office in 2014, and that can leave the RSS with a giant-sized headache. A big part of the RSS s expected concern is that these elections potentially cast a shadow on the BJP s chances in the 2024 Lok Sabha elections.

In the earlier Assembly polls on Mr Modi s watch, the expected results were usually a matter of guesswork, with clear bets hard to make. Else, they were thought to be weighted in the BJP s favour even if the outcome turned out an anti-climax. We saw the latter most vividly in Gujarat in 2017 when the Conjunction gress nearly snatched the state from the saffron party though its campaign was led all the way by Rahul Gandhi, who had been written off as a bumbling spectacle.In contrast with preceding elections, this year s polls seem to have a very different flavour. No matter what the end outcome

matter what the end outcome in the Modi era this usually means the BJP buying up MLAs of other parties postelection and earning praise for this from the elite for showing chutzpah there is an emerging feeling that the ruling party is not looking dominant on the ground. In public perception, its stock is



down. In Uttar Pradesh in particular, there appears to be a wide measure of agreement among observers -- a shared belief almost -- on these lines. UP is always important, but is especially so this time around. Most BJP MPs, the PM included, won from this state. Hinduism s most vaunted pilgrim sites and religious symbols, which the BJP has sought to milk to buttress its communal appeal, lie here. The BJP won the state by a yard and more in the 2017 Assembly polls. In short, if there is a setback for the ruling party in UP, ominous signs for it are likely to be read nationally, affecting all-round political dynamics, casting gloom in the ruling party s top leadership as well as its rank and

file, even if state polls aren t

necessarily a predictor of national results.

Ordinarily, after seven years in power, an electoral setback is deemed quite normal. Anti-incumbency is common in democracies. But Mr Modi has run the show in a highly personalised, superdominant style, with a centralising, homogenising, focus. He has built a cult of personality. He lives in many avatars simultaneously. He has sought to create an aura of being unstoppable. If the voter administers a shock even to this carefully manicured personality despite its charms, then there s a question: Is the BJP s future safe with him? The RSS can hardly duck that question. The Sangh, which sets the BJP s ideological moorings and away from

the glare guides its political destiny, lives in the shadows. It is thought to be a careful tracker of the public mood. Without being conspicuous, and frequently shunning overt publicity, it manipulates the BJP s organisational strings. Its silent cadres work hard to shape opinion to advance the BJP s agenda, through calibrated media interventions and so-

cial media bold-facing.

In the months before the 2014 Lok Sabha elections, in pursuit of the Hindutva agenda, the RSS decided to hand the baton in the PM stakes to Mr Modi, then Gujarat s CM. This was accomplished by ensuring the sidelining of potential rivals like Lal Krishna Advani, Murli Manohar Joshi, Nitin Gadkari, Rajnath

Singh, and from among the younger set Arun Jaitley and Sushma Swaraj.

No one was left in any doubt that it was the Gujarat CM alone that the RSS was pitching for. Then everything fell into place in the BJP. The episode established yet again that only the RSS s writ runs in the BJP.

If anything prospered under Mr Modis stewardship as PM, it was the Hindutva agenda. There is a question mark on nearly everything else most notably the economy, the employment and inflation situation; even the handling of national security; until six months ago the handling of the Covid-19 pandemic; and decidedly the mishandling of the farmers question and of their year-long agitation.

Also, Centre-state relations have nosedived. Social cohesiveness has taken a beating due to the attempt at deepening fissures as between religious as well as social communities. Official data cannot hide the fact that nearly every section of India, except the very rich, has been pushed down at least one step on the economic ladder. Impoverishment of the people is the motif of the Modi Raj.

On the plus side for Hindutva, Ayodhya was a low-hanging fruit but Kashmir was not. But it s now in the bag, thanks to the PM s manipulative cleverness. The RSS cannot but be very satis-

fied. For the foreseeable future, however, there is no clear objective of a similar order in view which needs to be worked at right away.

worked at right away.

Indeed, Mr Modi himself appears to have moved on to other things—such as perpetuating his agenda of continuance in office through the outsize use of relentless propaganda.

Is this in accord with the RSS organisational ethos, that places primacy on the utility value of leaders in its constellation rather than their image or aspirations? Remember, Atal Behari Vajpayee whose persona had a spread outside the RSS s cloister system is not an automatic favourite of the Sangh Parivar due to his per-

ceived catholic temperament.

Mr Modi has lived his politics and governance on his own terms so far. How does the RSS view him? The answerisn t evident, although we do know that its leader Mohan Bhagwat, in an address from New Delhi s Vigyan Bhavan, had made barely camouflaged critical observations on the government s handling of the pandemic last summer. On the year-long farmers agitation too, the RSS had to intervene at various levels to get the government off its high horse.

It appears that in the RSS s reckoning, the Modi government has adopted a work agenda that hasn t brought dividends.


Early signs of pancreatic cancer that you must not ignore

Pancreatic cancer is a nasty, stubborn killer that has thus far defied medicine s best efforts at early diagnosis and curative treatment. In November, it claimed the life of my friend Peter Zimroth, a 78-year-old New York City, US, attorney who was devoted to public service.

Zimroth was fit and active and in otherwise good health before symptoms developed in his case, stomach pains and constipation. By that time, the cancer had spread and it was too late to operate.

Although pancreatic cancer is a relatively rare cancer, it is so deadly that it is now on track to become the country s [the US s] second leading cause of cancer-related deaths by 2040. Currently, it accounts for about 3 per cent of all cancers and 7 per cent of cancer deaths. Overall, only 1 in 10 people diagnosed with pancreatic cancer survives five years. A cure is almost always a lucky accident, when the cancer is detected at an early, symptom-free stage during an unrelated abdominal scan or surgery and the tumour can be surgically removed.

Dr Brian Wolpin, director of the gastrointestinal cancer centre at the Dana-Farber Cancer Institute in Boston, US, told me that this is such a hard cancer to find early because it s relatively uncommon in the population and the symptoms it causes, like weight loss, fatigue and abdominal discomfort, are nonspecific and more likely due to other conditions. As a result, he said, When 80 per cent of patients walk through my door for the first time, I know that we are highly unlikely to cure their



Risk factors

Still, there are several major risk factors for developing pancreatic cancer. Smoking doubles the risk and accounts for about one-quarter of all cases. Being obese, gaining excess weight as an adult and carrying extra weight around the waist, even if not otherwise very overweight, also increase one s risk.

That may be why type 2 diabetes most often related to being overweight is an important risk factor as well. Other risks include chronic pancreatitis, a persistent inflammation of the pancreas often linked to heavy alcohol consumption and smoking, and workplace exposure to certain chemicals, including those used in dry cleaning and metal work industries.

Older age is also a risk factor and family history may play a role too, including inherited genetic conditions such as mutations in the BRCA1 or BRCA2 genes that are most often associated with breast and ovarian cancers.

eurobics is slowly finding relevance in the world of fitness. It is defined as activities designed to stimulate the brain, memory and cognitive function. Gone are the days of all brawn and no brain at the gym. Research is slowly unravelling the link between repetitive complex movements of the body and how it might help in cognitive restoration (in the senior population) and development (in the younger one).

Karate Katas A Kata in classical Japanese Karate is a series of intricate movements conducted in a rhythm involving changes of stance while performing techniques. Although widely considered as ineffective in a real fight, Kata has far greater implications in terms of balance. focus, breath control and neurobics. Kata, once learnt, can be practised alone and without any other fitness aids. Memorising and synchronising complex movements and the focus that is needed to maintain balance, timing and rhythm, aid in improving concentration. ithout any intention, gentle reader, to seem immodest, I venture to tell you about my latest foray into fiction. I am engaged in writing a book with the mildly derivate title Uncle Ton's Cabinet . No, it s not a book about an antique cupboard, it s a foray into the world of UK politics

under the prime ministership of a character I have named Gojo.

In this yarn, in deference to modernity, Gojo has recruited ministers from the Asian, black and Middle Eastern stock of British citizens. Even though these are elected members of Parliament and, by definition, representative of the con-

stituencies that elected them, they are certainly as representative of the ethnic communities of Britain as Jeff Bezos or the electric car fellow Elon Musk is of the poor and starving of the world.

Readers may have noticed the similarity of my intended title to that of the famous nineteenth century novel by Harriet Beecher Stowe called Uncle Ton's Cabin. To be an Uncle Tom has come to mean to be an arse-licker and someone whose cowardice and attitudes amount to a betrayal of his or

her own people. Take, for instance, the leading female character of my literary enterprise whom I have so far, in this first incomplete draft, called Uglii Clueless Motel. She is so called because her Asian parents inherited the surname by running a motel in Uganda before they were expelled from that country by Idi Amin. She is an extremely strong character—one can thave weak women in novels these days without being pilloried and cancelled—and as home secretary is the most virulent anti-immigrant minister Britain has had since Heinrich Himmler! Bajrang Dal activist murder case: K'taka dist inching towards peace

SHIVAMOGGA: After witnessing large-scale violence following the murder of 28-year-old Bajrang Dal activist Harsha, the Shivamogga district is limping back to normalcy. All curfew curbs have been lifted. The district administration, however, will keep prohibitory orders in place till Sunday with all schools and Monday. Meanwhile, the special teams formed to probe the case have made two more arrests taking the number of arrested persons to ten. The arrested have been identified as Abdul Roshan (24), a resident of Bhadravathi town and Jafar Sadiq (55) from Shivamogga city. Shops and commercial establishments in Shivamogga are allowed to operate between 6 a.m and 4 p.m on Saturday. However, heavy police presence will continue in the city to ensure absolute restoration of peace. Two cars and a bike used for the murder by the accused have been recovered. The police informed that the registration numbers of these vehicles do not belong to Karnataka The special teams have zeroed in on the girls who allegedly made last calls to Harsha seeking help to trap him. However, during the preliminary inquiries, the police could not find any connection between the girls and the murderers, sources said. A search is on for the deceased Harsha's mobile which has gone missing. Youths who flashed weapons before the police have also been identified and will be taken into custody. Curfew was imposed from Monday, after murder of Harsha on Sunday night. According to police, the killers had made new weapons, including machetes, to hack Harsha to death in a furnace located in Bhadravathi town. The killers had followed Harsha in a car on last

Indians in Ukraine advised not to move to border posts NEW DELHI: In a latest advisory by the Indian Embassy in Ukraine, Indian citizens in the

war-torn country were on Saturday advised not to move to any of the border posts without prior coordination with the Indian government. "All Indian Citizens in Ukraine are advised to not move to any of the border posts without prior coordination with Government of India officials at the border posts (helpline numbers established) and the Emergency numbers of Embassy of India, Kyiv," the advisory read. The armed conflict between Russia and Ukraine intensified in the early hours of Thursday after Russian forces launched a major assault on Ukraine, firing missiles on cities and military installations. The Indian Embassy further said that the situation at various checkpoints is sensitive and the Indian Embassy in Ukraine is working continuously with embassies in other countries for evacuation of Indian citizens. The advisory noted that the embassy is finding it very difficult to help the crossing of those Indian nationals who reach border checkpoints without prior intimation.



Ponzi scheme: Guj woman held for duping around 700 for over Rs 4 cr

NEW DELHI, FEB 26

The Economic Offences Wing of Delhi Police has arrested a 48woman misappropriating the funds of the people and cheating them to the tune of over Rs 4 crore, an official said on Saturday.

The accused was identified as Sunita Saini, a resident of Surat, Gujarat.

Furnishing details, Joint Commissioner of (Economic Offences Police Wing) Chhaya Sharma said the complainant had levelled allegations against Vashundhara Group, allegedly a financial institution functioning Azadpur, Delhi for misappropriating their funds on false representation of doubling invested money in 4 years.

"The accused Sunita Saini is Director and share holder in the alleged company," the Jt CP

According to the senior official, the alleged group and



its owner and directors Chandra Prakash Saini alias C.P. Saini, Sunita Saini & others, allured the general public to open daily saving account, fixed deposit account and other lucrative investment schemes and following the directions of the accused, the victims fell prey and opened the accounts (likewise banks).

They were issued certificates, pass books, etc against investments and the deposits.

"Around 700 victims have been cheated to the tune of more than Rs 4 crore as on date. The amount and victims are increasing on day basis. Thereafter, C.P. Saini and his wife Sunita Saini ran away with the invested funds of the victims," Sharma said.

Accordingly, the police registered an FIR under

sections 409, 420 and 120B of the Indian Penal Code and took

up the investigation. During investigation it was revealed that Vasundhara Fintech Ltd & Anakaya Nidhi Ltd (the accused companies) and its directors collected funds from the victims on the promise of fixed returns and the accused companies acted as a NBFC. Whereas, alleged company was neither registered as NBFC with RBI, nor could it take deposit from general public. Further probe revealed that the accused person was absconding since last 6 months. "Technical surveillance was mounted on several suspect numbers and minutely analysis of targeted Facebook accounts enabled the team to locate the whereabouts of accused person at Surat, Gujrat," said the official.

Subsequently a raid was carried out in Surat, Gujarat from where the accused was apprehended and later arrested. Further investigation is on, the

Maharashtra finances not robust, but salvageable with 'discipline'

MUMBAI, FEB 26

As the Maha Vikas Aghadi (MVA) government readies for its third annual Budget (2022-2023) in early March, the focus is again on the state of the state's finances. The state has been grappling - ranking among the worst-hit - with the ongoing Coronavirus pandemic and the series of lockdowns that have played havoc with the economy, revenues and expenditure, and diversion of most resources to the health sector for the masses reeling under the impact of Covid-19. Till the previous fiscal (2020-2021), the state had notched up a whopping debt of Rs 520,717 crore, mostly comprising unpaid loans and other liabilities. However, the fiscal deficit percentage vis-avis GSDP is 2.1 per cent and the debt stock to GSDP is 19.6 per cent - well within the prescribed limits of 25 per cent, as per the Fiscal Policy Strategy Statement of last year, according to the official data.

Though appearing huge, the debt figures are an accumulation of the past several years owing to various factors. The average annual addition is in the range of Rs 65,000 cr," said Dr Ratnakar Mahajan, wellknown economic expert and former Executive Chairman, Maharashtra State Planning Board. Unlike many other states. there are no money-guzzling 'populist schemes' operating in Maharashtra - barring one important welfare measure started in Jan/2020 - the affordable meal of 'Shiv Bhojan Thali' - which was extended and heavily subsidised after the pandemic lockdowns were imposed in March 2020. A pet venture of Chief Minister Uddhav Thackeray, the 'Shiv Bhojan Thali' - on which the state government has spent less than Rs 500 crore in the past 24 months - proved to be a life-saver for the urban-rural poor and the lakhs of migrants on the move in the early days of the lockdown series. However, officials say the debt has to be serviced without fail every year - which is the expenditure part of the annual budget - but there is scope for being prudent, said an official of the state Finance Ministry, headed by Deputy Chief Minister Ajit Pawar.

On the eve of Kerala's new State Finance Minister K.N. Balagopal preparing the text of his first full state budget on March 11, the biggest cause of concern is the state's mounting outstanding debts, which according to the budget for 2021-22 will be Rs 3.27 lakh crore by the end of this fiscal. Outstanding debts is the sum total of public debt which consists of internal debt, loans and advances from centre besides loans from financial institutions such as LIC and special securities and not to mention of borrowings from deposits in state PF, treasury, pension funds and insurance. Even when the overall picture of Kerala's finances was never rosy, it took a severe blow like the rest of the world with the Covid pandemic, leaving the cash crunched

state in an even piquant position. To get a clearer picture of the debt, it is best highlighted as a ratio of the size of the state economy/state gross state domestic product (GSDP). A comparison of the national picture of states and union territories with the highest debt GSDP ratio in 2022 are Arunachal Pradesh 57.4 per cent, Kashmir 56.6, Punjab 53.3, Nagaland 44.2, Himachal Pradesh 43.4, Rajasthan 39.8, Meghalaya 39.2, West Bengal 38.8, Kerala 38.3 and Andhra Pradesh 37.6. One thing what has to be noted is the present staggering figure of the outstanding debts of Kerala did not happen overnight and successive state governments to a certain extent can take credit for the achievements of the state in the fields of education and

Telangana financially on a firm footing

HYDERABAD, FEB 26

Despite the dent in revenues during the last two years due to Covid pandemic and lack of help from the Centre, Telangana financially appears to be on a firm footing. With a higher growth rate and per capita income than many bigger states, India's youngest state has become the fourth largest contributor to national GDP in a short span of less than eight years and claims to be a model for the entire country in welfare and development.

According to 2020-21 budget estimates, Telangana's estimated outstanding public debt will be over Rs 2.86 lakh crore. However, the economists say the state has the capacity to manage debts.

According to a study paper released by the Reserve Bank of India (RBI) last month, Telangana's debtto-GSDP ratio is the lowest in the country, indicating the fiscal health of the state



between 2014-15 and 2018-19, the study paper revealed that the State Performance Composite Index (SPCI) of Telangana has improved. SPCI measures both the performance and fiscal market development of states. The average debt to Gross State Domestic (GSDP) Product (GSDP) of Telangana from 2014-15 to 2018-19 was 16.1 per cent, which is the lowest among the states in the country.

According to state finance minister T. Harish

state Assembly last year that Telangana's debt burden is only 22.8 per cent of GSDP, which is well within the permissible limits under the FRBM Act. Telangana was then at the third place from the bottom in the country.

burden is just 22.8 per cent of GSDP," he had stated. The RBI also revealed recently that Telangana is the fourth largest contributor to the economy. According to "Handbook of Statistics on the Indian Economy 2020-21" the Net State Value Added (NSVA) by Telangana at current prices to the country increased from Rs 4,16,930 crore in 2014-15 to Rs 8,10,503 crore in 2020-21.

Leaders of ruling TRS say this contribution is significant considering the fact that Telangana is the 11th largest state in terms of geographical area and 12th in terms of population.

According to Telangana State Statistical Abstract Report released this week, provisional estimates show the GSDP of Telangana at current prices in 2020-21 was Rs 9,80,407 crore. Between 2012-13 and 2020-21, the average annual GSDP growth of Telangana

The state's public debt rose to 31.38 per cent between 2019-20 and 2020-21, creating a precarious financial situation. The result of the pandemic has been such that, according to the 2020-21 finance and appropriation accounts report published by the Comptroller and Auditor General (CAG), the government recorded a drop of Rs 14,535 crore in tax collection. The total debt of the state went up from



Rs 3.19 lakh crore to Rs 3.97 lakh crore, an increase of Rs 78,000 crore, forcing the government to put some ambitious and populist programmes in abeyance. Losses incurred in SGST, state excise duty, sales tax, stamps and registration and vehicle taxes. However, the non-tax revenue increased marginally from Rs 7,681 crore to Rs 7,894 crore. According to Ministry of Statistics and Programme Implementation, the growth of GSDP has decreased

by 9.28 per cent in 2019-20 and 2.23 per cent in 202-21 from 10.71 per cent in 2017-18 and 11.50 per cent in 2018-19. The government had to deal with a severe drought situation when it assumed power in 2019, and then adding more woes, half of the state was affected by flood fury. Later, the Covid pandemic further complicated the financial situation of the state. During the tenure of Chief Minister B.S. Yediyurappa, no major populist programmes could be doled out. Presently, his successor Chief Minister Basavaraj Bommai has a tough job in hand as he is to present an election year budget on March 4. The CAG report also shows that the government had to increase its borrowings. Effectively, the resultant impact has pushed the interest component to Rs 22,666 crore or 14.6 per cent of the state's

Rs 1.56 lakh crore. The CAG has also noted that 13 projects of irrigation, 41 of roads, three of bridges and one in others category remained incomplete for over five years. Ashwathnarayan, state BJP General Secretary, told IANS that as political parties are in the race to woo voters with social welfare schemes and freebies on the lines of Tamil Nadu and Andhra Pradesh, CM Bommai is inclined towards middle class and the upcoming budget is not going to be a fancy budget. When asked whether the BJP is not under pressure after Delhi Chief Minister Arvind Kejriwal delivered free essential services to people, he said that Delhi is a mini state, it does not include farmers, mass transport system, irrigation projects, law and order system and even medical education.

UP's total outstanding debt shot up by nearly 39% in five years

LUCKNOW, FEB 26

The Yogi Adityanath government in Uttar Pradesh has been borrowing so heavily from the market that its total outstanding debt has shot up by almost 39 per cent in five years. However, spending on education declined while spending on health increased only marginally during this period. What is even more surprising is the fact that in four out of five years, the state government was unable to spend even the full budgeted amount, leading to a revenue surplus. The full support given to the Yogi Adityanath government by the Narendra Modi government -- the so-called 'double engine' advantage -- also does not seem to have helped, either in terms of finances or in planning. According to the latest data available with the Reserve Bank of India, which compiles state government finances, the UP

government has outstanding liabilities worth as much as Rs 6.5 lakh crore, as estimated in the state Budget for 2021-22. This is 38.3 per cent more than the Rs 4.7 lakh crore debt it inherited when it took over in 2017. The bulk of this debt mountain is owed to financial institutions, such as banks. These are called market borrowings and are taken at hefty rates of interest. According to sources in the state finance department, a report by the Comptroller and Auditor General (CAG) on UP government's finances, released last month, pointed out that of the total public debt at the end of 2019-20, Rs 1.99 lakh crore (or 47.7 per cent of the total) would be payable after seven years. The CAG report referred to earlier made a shocking revelation. The state government transferred a princely sum of Rs 71,000 crore from a sinking fund illegitimately to its "non-tax revenue' head in its books in March 2020.

Every child born in Harvana is saddled with a debt of Rs 1 lakh. This is true with the estimated total debt on the state increasing to over Rs 2.29 lakh crore. The main opposition Congress, which was at the helm for a decade till 2014, has been blaming the BJP-JJP government for pushing the state into debt and taking it towards bankruptcy. As per official figures, the state's debt was Rs 70,931 crore in 2014-15 when the BJP assumed power in the state for the first time. The interest burden is also high, she pointed out. As per the FY22 budget papers, the state's revenue receipts is estimated at Rs 2.02 lakh crore. The expenditure on account of Subsidies and Transfer for FY22 was estimated at Rs 1,14,632.71 crore. Tamil Nadu is one of the debt laden states with its borrowing as on March 31, 2022, standing at Rs 5,77,987 crore. The credit rating agency Care Ratings, in a recent report, said that Tamil Nadu has borrowed a sum of Rs 62,400 crore between April 8, 2021 and February 22, 2022. In order to have a steady source of finance, the Tamil Nadu government wants the Goods and Services Tax (GST) compensation regime to be extended till June 6, 2024 from June 30, 2022. In his maiden budget speech Rajan said the government has plans to borrow Rs 92,484.50 crore during FY22. The expense towards interest payment and servicing of debt for FY22 was estimated at about Rs 44,700 crore. During the past 10 years. instead of borrowing for capex, the state borrowed to the salaries of government employees and pay back old debt by fresh borrowings, Rajan had said.

How W.Bengal put brakes on growing fiscal deficit

KOLKATA, FEB 26

With only a few days to go before the state budget, it would be interesting to watch how state financial advisor Amit Mitra put brakes on the growing fiscal deficit in the state. Experts are of the opinion that the state financial condition was showing signs of recovery despite the outstanding liabilities but the financial burden caused by the social schemes announced by the state is having a negative impact on the financial health of the state. The revenue deficit has been pegged at Rs 26,755.25 crore which is more than three per cent of the



Gross State Domestic Product (GSDP) limit. Going by the past trend, the figure is likely to increase further. The fiscal deficit shot up from Rs 52,350.01 crore in 2020-21 to Rs 60,863.96 crore in 2021-22. The upswing in deficit is expected, considering that

both the state's tax and non-tax revenues have plummeted during the pandemic. The state's own tax revenue dropped from Rs 60,669.37 crore in 2019-20 to Rs 59,886.59 crore in 2020-21 and its share in central taxes plunged from Rs 48,048.40 crore to Rs 44,737.01 crore during the same period. The period also witnessed a fall in non-tax revenue from Rs 3,212.90 crore to Rs 2,466.31 crore. Given the pandemicinduced fall, the budget estimate of Rs 50,070.29 crore as state's share in central taxes. Rs 75,415.74 crore as its own tax revenue and Rs 4,611.72 as its non-tax revenue, appear

salvageable with 'discipline' **MUMBAI, FEB 26**

As the Maha Vikas Aghadi (MVA) government readies for its third annual Budget (2022-2023) in early March, the focus is again on the state of the state's finances. The state has been grappling - ranking among the worst-hit - with the ongoing Coronavirus pandemic and the series of lockdowns that have played havoc with the economy, revenues and expenditure, and diversion of most resources to the health sector for the masses reeling under the impact of Covid-19.

Till the previous fiscal (2020-2021), the state had notched up a whopping debt of Rs 520,717 crore, mostly comprising unpaid loans and other liabilities. However, the fiscal deficit percentage vis-a-vis GSDP is 2.1 per cent and the debt stock to GSDP is 19.6 per cent - well within the prescribed limits of 25 per cent, as per the Fiscal Policy Strategy Statement of last year, according to the official data. "Though appearing huge, the debt figures are an accumulation of the past several years owing to various factors.

The average annual addition is in the range of Rs 65,000 cr," said Dr Ratnakar Mahajan, well-known economic expert and former Executive Chairman, Maharashtra State Planning Board. Unlike many other states, there are no money-guzzling 'populist schemes' operating in Maharashtra - barring one important welfare measure started in Jan/2020 - the affordable meal of 'Shiv Bhojan Thali' - which was extended and heavily subsidised after the pandemic lockdowns were imposed in March 2020. A pet

venture of Chief Minister Uddhav Thackeray, the 'Shiv Bhojan Thali' - on which the state government has spent less than Rs 500 crore in the past 24 months - proved to be a lifesaver for the urban-rural poor and the lakhs of migrants on the move in the early days of the lockdown series. However, officials say the debt has to be serviced without fail every year - which is the expenditure part of the annual budget - but there is scope for being prudent, said an official of the state Finance Ministry, headed by Deputy Chief Minister Ajit Pawar.

NEW DELHI: A woman trainee pilot died when an aircraft belonging to a private aviation academy crashed in Nalgonda district of Telangana on Saturday, police said. Aviation Minister Jyotiraditya Scindia said he was shocked and an investigation team is reaching the site of the accident. Citing preliminary information, a police official said the ill-fated aircraft, which came from neighbouring Andhra Pradesh side, crashed at a village in the district before noon. The woman trainee pilot died on the spot and further details were being ascertained, the official said. Scindia said on Twitter that he was shocked to hear about the tragic crash of a training aircraft in Nalgonda. "An investigation team has been rushed to the site. Huge decline in domestic gas subsidy borne by Centre in three years, reveals RTI

NAGPUR: The payment of gas subsidy by state-run oil marketing companies (OMCs) has plummeted to Rs 2,706 crore for the first nine months of FY22, from Rs 37,585 crore in FY19, an RTI query has revealed. The query was filed by Nagpur resident Abhay Kolarkar, who sought information from the Ministry of Petroleum and Natural Gas pertaining to subsidy provided to domestic gas consumers in the last five years. The subsidy burden on the government has reduced as it kept on increasing the retail prices of liquefied petroleum gas (LPG) which is used by over 39 crore homes for cooking, even as the global oil and gas prices showed a decline. This has been seen as an attempt at decontrolling prices of the fuel, in line with similar moves on petrol and diesel. The RTI reply revealed that in 2018-19, three state-run OMCs paid Rs 37,585 crore as subsidy, which came down to only Rs 2,706 crore in FY22 till December, Kolarkar told PTI. Kolarkar added that the price of a cylinder has increased by around 100 per cent in the last five years and the government has reduced the subsidy on gas.At present, the cost of a cylinder is around Rs 900, but subsidy paid is Rs 40.10 only. He sought immediate restoration of subsidies as a percentage of the total cost to help lessen the burden on the common man. Indian Oil Corporation (IOC), the largest of the OMCs, said its customers were given a subsidy of Rs 12,371 crore 2017-18, Rs 18,663 crore in 2018-19, Rs 13,048 crore in 2019-20, Rs 3,350 crore in

The bench told Additional Solicitor General Aishwarva Bhati, appearing for Centre and Enforcement Directorate, "We want you to tell us on affidavit whether cryptocurrency trade involving Bitcoin or any other such currencies is legal in India or not? Ukraine crisis: Government to bear cost of evacuating Indians



NEW DELHI, FEB 26

Air India will operate two flights to Romanian capital Bucharest to evacuate Indians stranded in Ukraine due to the Russian military offensive against it, senior government officials said. The transportation cost, they said, would be borne by the government. One flight would leave tonight from Delhi at 9 pm and the other from Mumbai at 10.30 pm. Both the flights are expected to return to their starting points before noon tomorrow, the officials said.

The citizens who have reached the Ukraine-Romania border by road will be taken to Bucharest by Indian officials so that they could be evacuated in the two Air India flights, they said. The officials said the government was focusing on evac-

Ukraine's land borders with Hungary, Poland, Slovakia and Romania as the Ukrainian government closed the country's airspace following the Russian military offensive. Nearly 20,000 Indians, mainly students, are currently stranded in the war-torn nation. The distance be-tween the Ukrainian capital Kyiv and the Romanian border is approximately 600 km and it takes anywhere between 8.5 to 11 hours to cover the distance by road, the officials said. "The distance from the Ukraine-Romania border to Bucharest is 500 km and it takes seven to nine hours to cover the distance by road. The distance between Kyiv and the Hungarian border check point is around 820 km and it takes 12-13 hours to cover it by road," the official said.



India needs to remain vigilant as neighbouring countries not polio-free: Mandaviya

NEW DELHI: Since the neighbouring countries are still not polio-free, India needs to remain vigilant and continue with its vaccination programme against the disease, Union health minister Mansukh Mandaviya said on Saturday, highlighting that door-to-door inoculation campaigns will be conducted to ensure that no one is left behind.

The minister, who launched the National Polio Immunisation Drive for 2022 by administering polio drops to children below five years of age in the Ministry of Health, said over 15 crore children aged below five years will be vaccinated against the disease in the coming months.

"India's strategic fight against polio is a success story of the country's public health policy against vaccine-preventable diseases. We need to continue to be vigilant and ensure that every child under five years of age must get polio drops," he said.

Under the leadership of Prime Minister Narendra Modi, the Universal Immunisation Programme



is focussing to protect children from more diseases than ever before and has introduced several new vaccines like the Pneumococcal Conjugate Vaccine (PCV), the Rotavirus vaccine and the Measles-Rubella (MR) vaccine in the recent past, Mandaviya

Further, to provide additional protection to children, the government has also introduced the

injectable Inactivated Polio Vaccine into its routine immunisation programme, he pointed out.

"While we are making efforts to

protect our children from more and more diseases, it is important that all vaccines under the programme reach every child of our country," the minister said.

Stressing the importance of observing the National Immunisation

Day, he said, "The aim of Swasth Bharat can only be achieved if our children are healthy. The objective of Mission Indradhanush or Polio Vaccination Drive is to protect our children against such deadly diseases. Since our neighbouring countries are still not polio-free, we should remain vigilant and continue the vaccination programme.

"Over 15 crore children of age less than five years will be vaccinated in the coming months. Door-to-door vaccination campaigns through robust micro-planning will be done to ensure that no one is left. I congratulate all the healthcare workers, stakeholders like WHO, UNICEF, Rotary Club and NGOs for making this immunisation programme a Lok Bhagidari Andolan as envisioned by our prime minister. I request all families to come forward to get their children vaccinated."

Union Health Secretary Rajesh Bhushan highlighted the achievements and the way forward to implement the National Immunisation Programme.

In Aqcha, a far-flanged district of the Jawzjan province, Hajji Bibi Nazira has built a 12-classroom school on 650 square meters of land at a cost of \$65,000, largely solving the school shortage for girls in the district, Xinhua news agency

She has become the first woman who built a girls' school from her own wealth since the Taliban took over the power of Afghanistan in mid-August last year.Local officials said local female students, who used to attend classes under tents, now have finally found a place to study with rooftops.

Provincial director of Education Department Mohammad Tahir Jawad told Xinhua recently that getting education is vital for everyone as well as for the whole society.

"The Islamic Emirate encourages education for girls and the new school has been built with the support of the government to promote education,"Tahir Jawad said.
