LIC lists at 8.11% discount at Rs 872

per share on NSE NEW DELHI: The coun-try's largest insurer LIC on Tuesday listed its shares at a discount of 8.11 per cent at Rs 872 per share on the NSE On the BSE, the shares got listed at Rs 867.20 apiece, down 8.62 per cent over the issue price of Rs 949 a share. LIC had fixed the issue

price of its shares at Rs 949 apiece after a successful initial public offering, which fetched Rs 20,557 crore to the government. LIC policyholders and retail investors have got the shares at a price of Rs 889 and Rs 904 apiece, respectively, after taking into account the discount offered. The shares got listed on the BSE and NSE on Tuesday at a discount of Rs 81.80 and Rs 77 apiece, respectively, over its issue price of Rs 949 a share.

The Supreme Court on Tuesday directed the Varanasi district magistrate to protect the area where an alleged shivling was found inside the Gyanvapi Mosque complex but said it should not impede access to the mosque to offer prayers. The court issued notices to the Hindu petitioners and the Uttar Pradesh government on the plea of the Anjuman Intezamiya Masjid committee, which manages the affairs of Gyanvapi mosque, chal-

lenging the local court order that directed videographic survey of the



masque. The court-appointed special Commission has also received two-more days to submit the survey report.

"Court has granted two days time to submit the report. He (Advocate-Commissioner Ajay Kumar Mishra) was not cooperating," Assistant Court Commissioner Ajay Pratap Singh told ANI.

The Commission had sought two-days time to submit the sur-

vey report. "We had sought two days' time from the court. The Court has granted us two days' time for submission of the report," Advocate Vishal Singh, the Court-appointed special assistant commissioner said. The survey lasted for

The Supreme Court heard the plea seeking a stay on the survey of the Gyanvapi Mosque complex in Varanasi today and observed that till the next date of hearing, they will issue a direction that DM Varanasi will ensure that the Shivling area will be protected but it will not impede access of Muslims to the mosque for prayers.

The Central Bureau of Investigation has registered a case against five accused including private persons based in Chennai, Mumbai, private companies based in Mumbai, Mansa (Punjab), etc and unidentified public servants and private per-

sons. The accused include Congress leader Karti P Chidambaram.

As per the CBI, the case has been registered on certain allegations including bribery to facilitate the issuance of a visa to a Chi-

nese company beyond the ceiling.

The other four accused in the case have been identified as S Bhaskararaman (close associate) based in Chennai, Vikas Makharia, representing Mansa (Punjab) based private company, M/s Talwandi Sabo Power Limited, Mansa (Punjab), M/s Bell Tools Limited, Mumbai (Maharashtra), and other unidentified public servant(s) and private person(s).

"It has been alleged that the private company based at



The Haryana government has also been asked to file its reply on Khemka's plea against the FIR. Justice Avneesh Jhingan of the HC has passed these orders while hearing a petition filed by Khemka seeking quashing of FIR registered against him on April 26 at Panchkula under the prevention of corruption act .

Gold jumps Rs 388; silver rallies Rs 1,046

NEW DELHI: Gold price in the national capital on Tuesday jumped Rs 388 to Rs 50,282 per 10 gram, reflecting rally in international precious metal prices, according to HDFC Securities . Defence Minister Rajnath Singh, on Tuesday, launched two frontline warships of the Indian Navy - 'Surat' and 'Udaygiri' - at Mazagon Docks Limited (MDL) in Mumbai and praised the efforts of the Indian Navy for its continuous efforts towards 'Aatmanirbharta'. 'Surat' is the fourth Guided Missile Destroyer of the P15B class, while 'Udaygiri' is the second Stealth Frigate of P17A class.

In his address at the launch of frontline warships, Singh described the warships as an

embodiment of the government's unwavering commitment to enhancing the country's maritime capability, while focussing on 'Aatmanirbharta'. The Defence Minister appreciated the fact that the Indian Navy has always been at the forefront in ensuring self-reliance through the manufacturing of indigenous ships, submarines, etc. "Joining hands with initiatives like 'Make in India', the Navy has given 76 per cent Acceptance of Necessity (AON), and 66 per cent cost-basis contracts to Indian vendors in 2014, and the indigenization of about 90 per cent of the Naval ammunition has taken place," he said.

HP orders CBI probe into Question paper leak case

AGENCY SHIMLA, MAY 17

Himachal Pradesh Government on Tuesday decided to hand over the police paper leak case to Central Bureau of Investigation (CBI) after it was found that the scam had links to people based in several other states of the country. The decision was

announced by the Chief minister Jai Ram Thakur here today. Briefing media on the issue Chief minister Jai Ram Thakur said that an SIT was constituted by the state government after it was discovered that candi-

dates who have qualified the exam including those who had topped the written examination could not even answer simple questions. After this a preliminary investigation was conducted, under which top eight students were grilled by the Police and they revealed the names of agents and source of the question paper leak. Chief minister said that examination was held on March 26, 2022 and around 75,000 candidates who qualified the physical appeared for the exam for around 1334 posts of constables in state police. An FIR was lodged at Kangra district on the alleged paper leak case. On the next day an SIT probe was constituted by the DIG central range, Madhusudan, it was found

that 73 people were involved in the paper leak including 38 students and two parents. 10 People were arrested from the ten different states as an interstate paper leak

was uncovered. The decision to hand over the probe to CBI was taken after deliberations by the Council of Ministers to ensure that the state police comes clean on this scam

which was essential to maintain the faith of common people on the state police which has so far done a commendable job to unearth the inter state gang.

Rs 100 crore changed hands in police recruitment paper leak scam: Agnihotri

Senior Congress leader and Leader of the Opposition in Himachal, Mukesh Agnihotri has raised questions on the Himachal Pradesh Police recruitment leak case during a press conference. While dubbing the case a major scam, Mukesh Agnihotri alleged that an attempt is being made to suppress the case, as it also includes the names of senior police officers.

Mukesh Agnihotri claimed that this paper was sold for Rs 6 to 8 lakh. This paper was leaked to about 1500 students. About Rs 100 crore changed hands in this whole matter. This department is with the Chief Minister and the Chief Minister is trying to suppress this matter, he said.



The Leader of the Opposition said that if lessons had been learned from the 2020 exam and strict action had been taken, such a major scam

would not have occurred now. Now the Chief Minister wants the examination to be held again as soon as possible

He said in Chandigarh and Haryana, papers were given to children so that they could learn it by rote. The faith of the people was betrayed. While taking a dig at the government, he said that the investigation is going on as to who bought the paper, while in fact it should have focussed on who sold the paper.

It may be mentioned that a written examination was held on March 27 for the recruitment of 1,334 posts of Himachal Police Constables. The result was announced on April 5. Papers were held in 81 examination centres across the state. On May 5, Kangra police had unearthed the case. Po-lice have so far arrested several accused from different states of the country in this case.



SDM holds meeting with agri officers over promotion of direct sowing of paddy

MAINPAL KASHYAP INDRI, MAY 17

Sub-Divisional Magistrate Dr. Anand Kumar Sharma held a meeting with agriculture officers and progressive farmers of various villages to promote direct sowing of paddy at the Municipal Council here.

He informed in the meeting that the time is coming for sowing of paddy in which paddy farmers prepare seedlings by traditional method and transplant paddy in the field from next 15th June.

However, due to high temperature at this time, due to excessive evaporation of water, water consumption is very high. In addition, transplanting paddy also takes more labour. This significantly increases the expenditure on paddy cultivation.

To reduce the amount of water and the cost incurred by the traditional method of rect sowing of paddy gives the same yield as sowing of

paddy, the farmers can do direct sowing of paddy through DSR machine. This will also save the falling ground water level. Sub-Divisional Magistrate Dr. Anand Kumar Sharma informed that in DSR method direct sowing of paddy is done in wet field. The first fortnight of June is suitable for direct sowing and the first watering is applied about 21 days after sowing. Sowing with this method saves 15 to 20 percent of water, reduces the problem of weeds and reduces the pro lem of iron due to deep roots. He told the farmers that di-

paddy in the traditional way, whereas by direct sowing of paddy the crop is ripe and ready 10 to 15 days in advance. He informed that awareness camps for direct sowing of paddy would be organized so that more and more farmers could be made aware about direct sowing of paddy through DSR machine. The Sub-Divisional Magistrate informed that he said that direct sowing of paddy also reduces the incidence of diseases and pests in the paddy crop.

Labour workforce and arhtiyas backbone of State's economic structure: Kataruchak

SHASHI PAL JAIN CHANDIGARH, MAY 17

' The labour workforce of the State is the backbone of its economic structure. Hence, its welfare is a priority with the Government which would leave no stone unturned to ensure its prosperity. The doors of the State Government are always open for them". These views were expressed here today by the Food, Civil Supplies and Consumer Affairs, Forest Minister Mr. Lal Chand Kataruchak here at Anai Bhawan in Sector - 39 while meeting the representatives of the labour unions.

On the occasion, the representatives of the labour unions demanded that the contract system be done away with the amount given directly to the labourers so that their living standard gets better. The Minister assured to look carefully into the matter. He also said that as far as the issue of modifying the basic rates being given to the labourers is concerned, he has already written to the Central Government in this regard and would personally take up the issue with the Government of India (GoI). He said that the State Government would also



strive for more better work conditions for the labourers. The Director of the department Mr. Abhinav Trikha on the occasion apprised that the matter pertaining to modifications in the basic rates has been sent to the central Government and is pending with them.

The Minister also afterwards had a meeting with the representatives of the Arhtiya Association of Punjab. The association put forward a demand that a sound policy regarding the tendering process is the need of the hour where the normal labourers, and the truck owners can also be equal participants thereby ending the monopoly of the contractors. Apart

from this, the parallel arrangements with regard to loading/unloading in the mandis must be made just in case the contractor exhibits negligence in the execution of the work. Besides. the arhtivas also made a case for increasing their commission as the MSP on crop has been raised to Rs. 2015 per quintal.

The arhtiyas also raised other issues such as lifting in the mandis, implementing per quintal uniform basic rates within 1 to 5 Km radius, loading/unloading in the timely manner, reforms in the policy regarding loading of foodgrains in the mandis apart from transportation, Putting restriction on the transportation of the specials pertaining to foodgrains and manure during the Kharif season for 1 month, work of transportation to the mandis and godowns should be assigned to the arhtiyas rather than contractors, cluster system must be abolished or small clusters be formed so as to put a stop to the self centered ways of the big contractors, basic rates of transportation and loading unloading be increased annually, and a policy be framed to get the work of transportation of foodgrains done through the arhtiyas.

The Minister gave a very patient hearing to all the demands put forward by the arhtiya association representatives and assured them of serious consideration in fulfilling the just demands as the arhtiyas play a yeoman's role in strengthening the economy of the State. Among others present on the occasion included Director, Food, Civil Supplies and Consumer Affairs Mr. Abhinav Trikha, President Food Handling Workers Union, Punjab (Moga) and Ex M.P. Following the issuance of a letter to all states by Union Ministry of Rural Development, with regard to discontinuation of centrally sponsored 'District Rural Development Agency (DRDA) Administration scheme' from April 1, 2022, resentment has been prevailing among the staff of the DRDAs throughout the state.

In its letter the Union Rural Development Ministry has written to the states to merge the DR-DAs with Zila Parishads/Zila Panchayats by absorbing the staff in these institutions while the staff working at the DRDAs on deputation can be absorbed back in their parent departments. However, Puniab Government has not reportedly taken any initiative so far to merge the DR-

from April 1, 2022. In such circumstances the staff of the DR-DAs is worried about their fate in future, besides the salaries for the month of April and onwards.

Punjab unit of All India DRDA Staff Welfare Association has already written to Chief Minister Bhagwant Mann to merge the DRDAs with Zila Parishads in all districts of the state as early as possible, but to no avails so far. President of Punjab unit of All India DRDA Staff Welfare Association Raj Kumar Singh said that the issue of merger of DRDAs with Zila Parishads is not new one as the Union Government had announced winding up of the DR-DAs several times in the past years also. He said the association had met Punjab Rural Development and Panchayats Mincently to resolve the issue. The minister had asked the Secretary of the department to do the needful but no progress has come to the fore so far in this direction, he added. Raj Kumar Singh further said that if the DRDAs were not merged with Zila Parishads at the earliest they would not be able to get their salaries from April 1, 2022 onwards. Besides, they would also be not able to make both ends meet. State president also urged the AAP Government to take decision, with regard to merger of the DRDAs with Zila Parishads, as early as possible. He also said that since 2005 the file of merger of the DRDAs with Zila Parishads was in process while the Finance Department had also given its approval in 2006 to merge the DR-DAs with certain conditions.

Registration of orphanages in district is mandatory under Juvenile Justice Act 2015: District Child Protection Officer

GURDASPUR (VERMA): Mrs. Neha Nair, District Child Protection Officer, Gurdaspur informed that if there is any children's home in District Gurdaspur in which orphans and destitute children between the ages of 0 to 18 years or Divyang children are living and they are in juvenile home Juvenile Justice. Action will be taken as per Section 42 of the Act 2015, which carries a penalty of one year or a fine of Rs. 1 lakh or both. He said that according to the Juvenile Justice Act 2015 enacted by the Government of India, any orphanage run



by a governmental or non-governmental organization in which orphans and destitute children between the ages of 0 to 18 years or Divyang children live and eat. , Educated must be registered under Section 41 (1) of the Juvenile Justice Act 2015. She said that for registration by governmental or non-governmental organization, a request letter has to be submitted to the Deputy Commis-

sioner of the concerned district under Juvenile Justice Act, 2015 (Protection and Care of Children). To be sent to the State Government for registration on the recommendation of the Deputy Commissioner, provisional registration is done by the State Government for a period of 6 months during the said period and permanent registration is done for 5 years after thorough scrutiny of the documents.

Neha Nayar District Child Protection Officer Gurdaspur informed that at present a Children's Home was running in District Gurdaspur under the Punjab Government.

SC directs ED to interrogate TMC leader Abhishek Banerjee, his wife in Kolkata

AGENCY NEW DELHI, MAY 17

The Supreme Court on Tuesday directed the Enforcement Directorate (ED) to interrogate Trinamool Congress (TMC) leader Abhishek Banerjee and his wife Rujira Banerjee in Kolkata instead of Delhi.

A bench of Justices UU Lalit. S Ravindra Bhat and Sudhanshu Dhulia said the ED has to give at least 24 hours prior notice to the couple before interrogation and simultaneously a notice shall be issued to the Commissioner of Police and Chief Secretary of Kolkata. AThe Supreme Court in an interim order stayed Delhi High Court March 11 order by which Banerjees' pleas against the issuance of summons by the ED were dismissed. The Court said it would not tolerate any kind of obstruction and interference by machinery if ED state interrogates the Banerjees in Kolkata. The apex court also issued notice to the ED on Banerjees' appeal against the High Court order and sought a



response within three weeks and posted the matter for hearing on July 19. The State of West Bengal assured the Supreme Court that complete assistance shall be rendered by West Bengal to ED officials. In case there is any interference, the ED shall approach the vacation court of the apex court, said the SC. The West Bengal government has assured that in case any complaint is filed against ED officials no coercive action will be initiated, noted SC in its order. The ED is conducting the investigation in a moneylaundering probe, linked to an alleged coal scam in West Bengal, in which the agency had issued summons to the Banerjee couple. Abhishek Banerjee, the nephew of TMC supremo Mamata Banerjee, had told the apex court that he is ready to be probed by the ED in Kolkata.

The Banerjees have challenged the summons issued to them by the ED for appearance here in connection with the money laundering probe linked to an alleged coal scam in West Bengal. They have requested the

top court to quash the summons and restrain the ED from seeking their presence for questioning in Delhi. They pleaded that they can be questioned by the ED at Kolkata and sought a stay on High Court's order. The petitioners have asked the apex court to decide whether the ED can assume pan-India jurisdiction to summon persons from anywhere to Delhi. "Whether the Respondent can assume pan-India jurisdiction to summon any person at the place of their choice, while exercising powers under Section 50 PMLA?," the plea questioned while adding that High Court has failed to appreciate that the couple is permanent residents of Kolkata and the entire alleged cause of action and the place of the alleged offence, is in the State of West Bengal. The search and seizure operations recorded in the FIR/RC took place in West Bengal wherein allegedly stolen coal was recovered and all the accused persons named in the FIR/RC are permanent residents of West Bengal, it added.

If such a person who is not associated with any institution and personally goes to any office and institution and covers himself as a media person, then legal action will be taken against him by the administration. Such a person should not be considered in the category of media. District Information and Public Relations Officer Sunil Bastara said that after holding talks with media persons and district administration officials, it was decided that some persons who do not have appointment letters of registered institutes from RNI and Ministry of Information and Broadcasting, government will not be included in the category of media personnel. He said that only the person of the registered institution is considered as a media person. If any person who holds the appointment letter of a registered institution, then he can submit it to the office of the District Information and Public Relations Officer. Such a person will also be informed of all the programmes. But some people are doing coverage in the field without any ID by personally posing as journalists in offices and institutions, which is wrong as per the rules. He said that it has been seen that some people do coverage of programmes with personal ID and their phones and they reach out to the institutions and authorities for coverage without any permission, which is wrong. He said that any media person who wants to get information from any officer and department can get information through the office of District Information, Public Relations Department.

India roasted

ndia is feeling the heat in ways other than the rising prices. The ongoing heatwave, in which tem-peratures have shot above 45 degree Celsius in many parts of northwest and central India, highlights the rising climate risks and their attendant costs. Heatwaves, beginning earlier than in the past, are part of a changing climate whose defining features, in addition to the gradual rise in temperature, are an increased frequency and intensity of extreme weather events. The human and economic costs of extreme heat conditions often go untraced and uncounted even as adaptation diffuses recognition somewhat. Summed across the population and over time however, the costs are significant. So are the macroeconomic consequences. The current heatwave illustrates some of these.

The most obvious is agriculture where the government has just banned wheat exports, the latest and sharpest in a series of responses to the shortfall caused by the sudden rise in temperature in mid-March, a critical time for crop maturity. Expected yield losses are about 15-20%, production is estimated to be 6% less than what was initially projected (111.32 million tonnes), with some reports stating that the internal assessment is less (98 mt) and that the struggling public procurement could be half the original target. Wheat proportions in the food subsidy scheme stand diluted, wheat allocations to 10 states under the food security law have been cut, procurement times extended, and quality specifications relaxed. Price pressures are never far behind output deficits and, predictably, wheat prices rose almost 10% year-on-year against 8.4% food inflation in April from 7.7% in March; wheat flour or atta prices have risen too.

Altogether, the supply-demand developments triggered by the unusual heat impact aggregate output and consumption. The macroeconomic consequences are significant because a large fraction of Indian labour is farm-based, low-earning, with a high marginal propensity to consume. Cumulative costs of such deviations in temperature rarely feature in the public discourse or are recognized, but studies over long periods capture substantial effects of increased temperatures upon crop yields, real wages and rural mortality rates. In this instance, besides denting the macroeconomic outlook and disrupting business plans, the sudden export ban has also damaged India's credibility because the prime minister himself stated recently that Indian exports would help resolve global scarcities

How greenhouse gas emissions can be reduced


ccording to a study by a team of Potsdam scientists, global food system needs to be transformed in order to drastically reduce greenhouse gas emissions

The group led by the Potsdam Institute for Climate Impact Research (PIK) used a quantitative food and land system model to gauge the effects of degrowth and efficiency proposals on the food sector's greenhouse gas emissions. They found combining a dietary shift, emissions pricing, and international income transfers could make the world's food system emissions-neutral by the end of the 21st century - providing at the same time a healthier nutrition for a growing world population.

"Just shrinking the size of our current food system won't cut emissions much. Instead, we need to transform the very nature of that global food system," said Benjamin Bodirsky, researcher at PIK and the World Vegetable Center in Tainan, Taiwan and author of the study.

That means on the one hand that people consume what they need in terms of nutritional requirements, curb food waste and eat a more balanced diet, with much more vegetables and fewer animal products. On the other hand, a qualitative transformation means more efficiency, hence producing food in a less-polluting way: smarter dosing of fertilizers or planting higher-yield crops. Also, carbon pricing could help steer farmers towards lower-emission agricultural practices, because emitting less than means paying less. Put together, this could drastically reduce greenhouse gas emissions," Benjamin Bodirsky added.

The way we produce food and manage our land is responsible for up to a third of global greenhouse gas emissions along the entire supply chain.



'So we looked at what this system would look like in a hypothetical degrowth world: On the basis of a review of degrowth proposals, we created a set of scenarios to feed into a food and land systems computer simulation to explore their effect on the food system," David Chen, researcher at the Potsdam Institute for Climate Impact Research and author

of the study, explained. "We took a step back from the heated normative debates about degrowth. What we found is that the current food system is basically unsustainable for any society, regardless of economic growth rates," David Chen stated.

The simulations show that simply curbing growth in rich countries would

not yield sizable sustainability benefits in the food system. Financial transfers from higher- to lower-income countries within the current development paradigm may even increase emissions. That is because carbon-intensive diet changes towards animal products and processed foods are most pronounced when countries move from low to medium incomes.

A sustainable diet benefits planet and people

Yet when the scientists included consumption changes and efficiency gains incentivized by a price on carbon, the results showed an improved nutritional outcome for all consumers, lower greenhouse gas emissions, and in consequence also less economic activity in agriculture required for food production.

"For the food sector, we can say that a certain degree of degrowth would be the result of the sustainable transformation, not the starting point. So basically this is not really about less but about dif-ferent growth," said Hermann Lotze-Campen, co-author from the Potsdam Institute.

Importantly, a sustainable food system transformation that takes into account all costs for the environment would entail a slight increase in food prices - felt especially by the poor, the scientists show.

Any transformation hence must be accompanied by a well thought out policy mix of smart taxing schemes, social compensation for CO2 pricing, and in-ternational transfers. Also, making agriculture more climate-friendly, e.g. by controlling nitrogen flows in croplands, requires investment. These costs, however, are likely offset by the restoration of ecosystem services.



On the last day, it confirmed support for 80W SuperVOOC charging, which can pump a day's worth of power into the battery in just 15 minutes. The battery capacity wasn't mentioned, but the leaks have it pegged at 4,500 mAh, reports GSM Arena. However, the latest announcement confirms the use of the Dimensity 1300 chipset. The chipset was unveiled a month ago and it is considered that the Nord 2T would be the first to use it.

The Dimensity 1300 is a successor to the Dimensity 1200, the chipset found inside the Nord 2. It is still a 6nm chip (from TSMC's foundries), it has four Cortex-A78 cores (one at 3.0GHz, three at 2.6GHz), four A55 cores (2.0GHz) and a Mali-G77 MC9 GPU. The next details that are speculated to be revealed are the flagship-level camera details. If rumours are to be true, the setup will feature a main cam using a 50MP IMX766 sensor (with OIS), an 8MP ultra-wide, plus a 2MP module on the back, along with a 32MP IMX615 on the front. The final reveal on the 19th, just before the event, will be about the screen (rumored to be 6.43" FHD+ 90Hz

73 yr brain stroke patient gets a new lease of life at lvy Hospital

mbala, May 17: A 73 year old man who suffered a brain stroke has been treated successfully with mechanical thrombectomy procedure at lvy Hospital, Mohali recently. Sharing details during a press conference at a hotel here

on Tuesday, Dr Vineet Saggar, Head of Neuro Interventional and Endovascular Neurosurgery at Ivy Hospital, who performed the procedure, said that the patient had suffered sudden onset of weakness while getting up from bed in the morning. Eventually he fell down and

was taken to a local hospital in Yamunanagar. The investigations revealed the blockage of the right internal carotid artery which supplies the majority of blood to the

right side of the brain, said Dr Saggar He was referred to Ivy Hospital, Mohali and reached there in an unconscious state during the evening.Since the 3 hours golden time to treat stroke was

passed the thrombolysis was not possible Patient was taken up for mechanical thrombectomy where the clot was removed directly from the vessel via Endovascular Neurosurgery without opening up vessels through devices passed from the groin, said Dr Saggar

Dr Saggar further informed that stroke is a major cause of disability in our country . Many stroke survivors especially in large vessel strokes remain bed ridden or dependent.

World over at least 1.4 billion people live with this chronic condition. In India, untreated and uncontrolled blood pressure, has become a leading cause for premature death and disability. The recently release National Family Health Survey (NFHS) 5 report reveals several alarming trends. Among them, the growing concern that more and more younger people are falling prey to hypertension. The findings also lend credence to the fact that although easy and affordable to treat, treatment adherence rate is the poorest.

Aortic aneurysm is silent killers because when they grow, person may be at high risk of immediate tough, durable workhorse, sometimes its walls can weaken and bulge in what is

called an aortic aneurysm. This could cause a leak that spills blood into your body. Some aortic





A head of the release of Akshay Kumar-starrer 'Prithviraj', the makers revealed that they had to create over 50,000 costumes and also used 500 different types of turbans during the shoot.

"Rarely do films take this much effort and embark upon such monumental tasks. Every element of our film which is based on the life of Samrat Prithviraj Chauhan has been dealt with utmost sincerity, authenticity and reverence.
