

ran, one of the six convicts in the Rajiv Gandhi assassination case on Sunday said that Congress leader Priyanka Gandhi Vadra met her in the jail and questioned her about the killing of her father Rajiv Gandhi. She further said that Priyanka Gandhi turned emotional and cried when she met her in jail. "Priyanka Gandhi met me in jail and she asked me about her father's killing. She got emotional for her father. She cried too," said Sriharan, while addressing a press conference. Sriharan, who is the longest-serving woman prisoner serving a life sentence in the country, was released from the Vellore jail on Saturday following an order from the Supreme Court on Friday, freeing all six convicts, including RP Ravichandran, in the case.

England beat Pakistan by five wickets to win the T20 World Cup title here on Sunday. Opting to field, England dished out a clinical bowling performance to restrict Pakistan to a below-par 137 for 8 before chasing down the target with six balls to spare at the MCG.

Pakistan never had any momentum in their innings. Babar Azam (32), Mohammad Rizwan (15), Shan Masood (38) and Shadab Khan (20) were the only ones who reached double figures. Chasing 138, England lost opener Alex Hales in the first over itself for just one run after Shaheen Afridi sent a delivery crashing through his gates. England was 7/1 in one

Flaunting arms banned in Punjab to curb flourishing gun culture

SHASHI PAL JAIN CHANDIGARH, NOV 13

In a bid aimed at checking gun culture and to maintain law and order in the state, the Punjab government led by Chief Minister Bhagwant Mann has ordered review of all the arm licenses in the state.

A decision to this effect has been taken after stern directions by the Chief Minister to discourage the use of arms in the state for maintaining peace, tranquility, law and order situation. On the directions of Chief Minister, the Principal Secretary Home has issued a detailed letter to Director General of Police, Police Commissioners, District Magistrates and Senior ents of Police ing them to review all the existing arm licenses in the state. It has also been directed that if any license had been issued to anti-social element, in the past, then it must be canceled immediately. Similarly it has also been ordered that no new license should be issued generally in the coming three months adding that license should be issued only where it is utmost and



genuinely required.

Even in that case also the issuing authority of arm license must be satisfied by the rational given by the applicant. Likewise, it has been ordered to impose a blanket ban on public display of arms and ammunition. This ban will also be applicable on all the social media platforms.

Similarly it has been direct-

ed that a complete ban should be imposed on the songs eulogising gun culture. Likewise ban must be imposed on carrying and display of weapons in public gatherings, religious places, weddings, parties and other. In the same manner the officers have been directed to organise special and surprise checking in the areas under their respective jurisdiction.

The officers have been directed that no one should be spared who is invoiced in hate speeches aimed at disrupting the peace and tranquillity.
Chief Minister had in May

warned those singers who allegedly promote gun culture through their songs. He disapproved of propping up such a trend and said those found involved will be dealt with sternly. He had condemned the "trend of gun culture and gangsterism being promoted by some Punjabi singers" and urged them "to desist from fanning violence, hatred and animosity in the society through their songs".

He had further called upon

such singers to follow the ethos and jabiyat thereby strengthening the bonds of brotherhood, peace and harmony "instead of fuelling anti-social activities through such songs"

Post a comment Early last year, then Punjab Chief Minister Amarinder Singh had backed the arrest of Shree Brar, a Puniabi singer who was accused of promoting gun culture and glorifying violence in a song.

cuss issues relating to global economy, energy, environment, digital transformation, etc. The summit is set to be attended by US President Joe Biden, British Prime Minister Rishi Sunak, French President Emmanuel Macron, German Chancellor Olaf Scholz and Chinese President Xi Jinping.

Gurmeet Ram Rahim's security increased

A heavy police force has been deployed by the Uttar Pradesh Police outside the Baghpat Ashram under the Binauli police station area of Gurmeet Ram Rahim to avoid any untoward incident.

The security of Dera Sacha Sauda's Barnawa Ashram located in the Baghpat district of the Indian state of Uttar Pradesh has been increased keeping in view the stay of the Dera chief, Ram Rahim in the Ashram.

Gurmeet Ram Rahim, head of Barnawa Dera Sacha Sauda Ashram, is serving a sentence for rape and murder in Rohtak's Sunaria Jail. He has been granted parole for 40 days and during this period, he will be staying at Barnawa's ashram.

Keeping in view the stay at the Ashram, the Uttar Pradesh Police has increased the security of Dera chief Gurmeet Ram Rahim.

Speaking about the heavy police force deployment outside the ashram, a servant at the camp informed that "searches are also being conducted on suspicious persons". Apart from this, "the crowd is also not allowed to gather around the ashram". The priority of the police is to prevent any untoward incident.

Hry to write to UP Govt for construction of Ganga-Yamuna canal these facts clearly indicate that de-

CHANDIGARH, NOV 13

The Chief Minister said that steps should be taken to bring water of the river Ganga to Haryana. For this, a letter will be written to the Ministry of Water Resources and the Uttar Pradesh Government for the construction of the Ganga-Yamuna Link Canal. With the construction of this link canal, additional availability of water will be ensured to Haryana, said Sh. Manohar Lal.

He further directed the officers of the Faridabad Metropolitan Authority to make plans for water harvesting through the Rainiwell project to meet the water requirement of Faridabad. Besides this, an expert committee should also be constituted, which will study the underground flow in Yamu-



na. Along with this, the Committee will also assess how much water is needed in South Haryana and how much is being supplied at present, said Sh. Manohar Lal.

The Chief Minister was apprised that the length of GWS is 69 km,

which off-takes at RD No-227800 of Delhi Branch from Kakroi Head and ends at Basai Water Treatment Plant. This channel was created in the year 1995 with a capacity of 175 cusecs. It serves the drinking water needs of Bahadurgarh, Gurugram and enroute 28 water works of Public Health Engineering, HSIIDC and Forest Department. Due to the continuous flow of water for 27 years, the lining of the channel is in a dilapidated condition. The lining is damaged badly and joints have opened through the length. This has significantly reduced the carrying capacity of the channel to 100 cusecs and is in dire need of repair.

The Chief Minister was further apprised that various departments also take water from this channel to meet the water requirements all

mand for drinking water in 2040 of Gurugram cities and towns en route would be around 475 cusecs. To meet this demand and to

avoid wastage of water, a project for remodelling of GWS channel along with augmentation of cusec capacity has been prepared. Water between Khubru and Kakroi is supplied by CLC, which has a capacity of 750 At present 1050 cusecs of water

is being released to Delhi, 400 cusecs of water is released to Gurugram and the remaining water is being used for irrigation. With the repair and remodelling of these channels, the total capacity will increase to 2300 cusecs, which will be able to meet the availability of water by the year 2030.

Parsing populism

opulist' is a useless term that needs to be retired. Over the past twenty years, it has been pressed into service to describe utterly dissimilar political figures and their movements. Bernie Sanders, Donald Trump, Recep Tayyip Erdogan, Rodrigo Duterte, Lula da Silva, Jair Bolsonaro, Viktor Orbán, Giorgia Meloni, Marine Le Pen and Narendra Modi are routinely described as populists as if they had some quality in common that was so defining that it made their obvious differences unimportant.

We don't have to be pundits or political scientists to see that Lula da Silva and Narendra Modi proceed from unlike political premises. Lula came to power and ruled as a politician committed to raising the living standards of Brazil's poor through the redistribution of wealth generated by Brazil's commodities boom. Narendra Modi came to power at the head of a Hindu supremacist party backed by a family of Hindu supremacist organisations.

All ruling parties and leaders are similar in that they discharge similar functions — law and order, welfare, taxation, foreign affairs — but it isn't hard to discern their principal ideological motivations if only because they trumpet them so loudly. Lula's redistributionist message has remained the same through two terms in office and, more recently, during his successful campaign for a third term as president. Modi, his party and its affiliated front organisations have been consistently hostile to Muslims and explicitly communal in their rhetoric and their use of the State to further their goal of a Hindu rashtra. To find an editorial or academic perch from which Lula and Modi (or Trump and Sanders) appear as two instances of a single tendency, two peas in a single categorical pod, suggests — a) a disabling distance from real life b) a commitment to definitions so abstract as to make ideology invisible or c) a mandarin centrism that makes the lumping together of campaigning redistributionists on the one hand and crusading supremacists on the other ideologically convenient.

The conventional definition of populism, a political position that invokes the People against a corrupt elite, is meaningless in the context in which it is most often used, namely electoral democracy. From Eisenhower to Biden, from Nehru to Modi, from Attlee to Sunak, from de Gaulle to Macron, it's hard to think of a single political leader who did not claim to represent the People or didn't promise to make distant political institutions more responsive to the aforementioned People.

Unrest continues in Iran

Thousands of Iranians have protested in the nation's southeast to a September crackdown by security forces known as "Bloody Friday".

Sune Engel Rasmussen, writing in The Wall Street Journal said that despite mass arrests and violence, Iranian authorities have failed to suppress the two-month-long protest movement that started after the death of a Kurdish woman, Mahsa Amini, who had been detained by morality police for allegedly flouting the Islamic Republic's strict dress code imposed on

More than 82 people died on Friday, September 30, as security forces cracked down on demonstrations in Sistan-Balochistan, rights groups say. The province is one of the largest and poorest in Iran and is home to an ethnic Sunni Muslim minority.

In recent days, hundreds of people have gathered in the provincial capital of Zahedan to mark 40 days--an important period in Islamic mourning--since the incident, which protesters have called "Bloody Friday.'

In one of the most serious challenges to the clerical establishment in decades, Protesters gathered in front of Zahedan's main mosque chanting "death Khamenei," the country's supreme leader, and "death to Basiji," a paramilitary militia tasked with protecting the Islamic Republic against domestic dissent, according to social media footage verified

by Storyful, which is owned by News Corp. Some protesters were chanting, "I will kill whoever killed my brother." Other videos featured the sound of gunfire that activists attributed to security forces opening fire on protesters, said Rasmussen.

At least 16 were killed last week in Khash, another city in Sistan-Balochistan, according to Iran Human Rights, a watchdog based in Oslo. More than 300 people, including around 40 minors, have been killed across the country since the protests erupted in September, Iran Human Rights said this week. The failure to suppress protesters across the country

is a sign that the movement remains a stark challenge to the Iranian leadership. Initially centred around demands to abolish the mandatory Islamic veil, or hijab, the movement morphed into calls to overthrow the Islamic leader-ship, reported The Wall Street Journal.

Protesters gather almost daily in some parts of the country, such as the western Kurdistan province where Amini was from. Elsewhere, such as in the capital Tehran, rallies are routinely held a couple of times a week, often in or around universities. In the past week, 227 of the 290 lawmakers in Iran's parliament called on the country's

judiciary to issue and carry out the death penalty for protesters. Iranian Chief Justice Gholamhossein Mohseni-Ejei asked judges to intensify and speed up sentences for hundreds of arrested protesters, said Rasmussen.

Authorities have sought to intimidate Iranians from participating in rallies by placing plainclothes police in the crowds to seize and arrest protesters.
One 32-year-old protest-

er in Tehran said on Friday she had been arrested twice by security forces in civilian clothing who pulled her out of a crowd. The first time she was held and interrogated for 10 hours, while police offi-

cers kicked her face and body. She was released when they didn't find any compromising material on her phone. The second time she was released more quickly, she said because the prisons were full, reported The Wall

"They are very danger-ous," she said about the plainclothes police, her voice breaking. "But that's not enough to stop us from protesting."

The protests in Sistan-Balochistan have been different in nature from rallies elsewhere in the country. The province is home to a Sunni minority and a separatist movement that the government in Tehran views as a terrorist organization.

Separatist slogans appear to have been largely absent from recent rallies in the province, but they have faced a more violent crackdown than elsewhere, activists say.

The protests in Sistan-Balochistan have also consisted almost exclusively of men, compared with other parts of Iran where women have been at the forefront. Women's rights activists in the province, where the protests every Friday have emanated from mosques, have objected on social media to the absence of women in the rallies, reported The Wall Street Journal.

Why older people are more susceptible to the flu

inflammatory lipid appears to reduce the number of macrophages inside the lungs with age. The study, led by first author Judy Chen, a Ph.D. candidate, stein, M.D., the Eliza Maria Mosher Collegiate Professor in Internal Medicine and Professor of Microbiology and Immunology, and their team investigates why cells called alveolar macrophages, the first line of defense in the lungs, appear to be compromised with age.

These macrophages are immune cells that attack invaders like the flu virus and live in the small air sacs, or alveoli, inside the lungs. Importantly, these cells appear to be lost with aging.

Previous research by another group showed that when macrophages from an old mouse were put into a young mouse, and cells looked young again. "This drove us to believe that something in the environment of the lungs is contributing to this," said Chen. Signs pointed to a



lipid immune modulator known as prostaglandin E2 (PGE2) with wide ranging effects, from labor induction in pregnancy to inflammation with arthritis. The study team discovered there is more PGE2 in the lungs with age. This increase in PGE2, Chen explained, acts on the macrophages in the lung, limiting their overall health and ability to generate. The team suspects that the buildup of PGE2 is yet another marker of a biological process called senescence, which is often seen with age. Senescence serves as insurance against the runaway division of damaged cells; cells that are senescent are no longer able to replicate. "One of

the interesting things about these cells is they secrete a lot of inflammatory factors," said Chen. The study showed that with age, the cells lining the air sacs in the lungs become senescent, and these cells lead to increased production of PGE2 and suppression of the immune response. To test the link between PGE2 and increased susceptibility to influenza, they treated older mice with a drug that blocks a PGE2 receptor. "The old mice that got that drug actually ended up having alveolar macro phages and had better survival from influenza infection than older mice that did not get the drug," said

Harsh winter awaits displaced families in Ukraine, Afghanistan

Afghanistan and across the Middle East displaced by conflict or persecution could face a perilous winter as freezing temperatures add to the misery already induced by spiralling prices, the lingering impact of the COVID-19 pandememe weather linked t mate crisis

UNHCR, the UN Refugee Agency, warns that for many of the world's forcibly displaced, this coming winter will be far more challenging than in recent years. Many displaced families will have no option but to choose between food and warmth as they struggle to heat their shelters, source warm clothing, and cook hot meals, according to UNHCR.

"Across the Middle East, many displaced Syrians and Iraqis will have to contend with extreme cold and snowstorms

This will be the 12th consecutive winter in displacement for many. UNHCR estimates that 3.4 million Syrian and Iraqi refugees and internally displaced people in Syria, Lebanon, Jordan, Iraq and Egypt will need critical assistance to prepare for and cope with winter," the UNHCR said in a statement this week.

In Lebanon, where the severe economic crisis is pushing everyone to the brink, nine out of 10 Syrian refugees are already living in extreme poverty, forcing them to reduce food consumption and suspend seeking medical care. Many are falling further into debt as they try to cover their basic needs. Millions of Ukraini-



ans uprooted from their homes by the current war are facing winter in displacement or are living in damaged homes or in buildings ill-suited to protect them from the biting cold, with disrupted energy, heating and water supplies and lost liveli-

In Afghanistan, where winter temperatures can easily plunge to -25 degrees Celsius across parts of the country, many displaced and conflict-affected families will be left exposed to the elements. Winter arrives amid a steep economic decline, and only months after June's earthquake in south-eastern Paktika and Khost provinces, in which thousands of people experienced devastating loss and damage to their homes.

Amid an ongoing effort to contain a humanitarian catastrophe, flash flooding and drought also continue to wreak havoc on lives, property and livelihoods, while some regions of Afghanistan continue to report new displacement.



Healthy plant-based meals are better for environment ccording to a new study led by researchers at Harvard T.H. Chan School of Public Health and Brigham and Women's Hospital, healthier plant-based dietary habits were associated with better environmental health, whereas less healthy plant-based dietary patterns, which are higher in foods like refined grains and sugar-sweetened beverages, required more cropland and fertiliser. 'The differences between plant-based diets

was surprising because they're often portrayed as universally healthy and good for the environment, but it's more nuanced than that," said Aviva Musicus, postdoctoral research fellow in the Department of Nutrition at Harvard Chan School and corresponding author of the study. "To be clear, we're not asserting that less healthy plant-based diets are worse for the environment than animal-based diets. However, our findings show that plant-based diets can have different



health and environmental impacts." The study, which is one of the first to look simultaneously at the health and environmental impacts of various plant-based diets, was published in the November 2022 edition of The Lancet Planetary

Previous research has documented that different types of plant-based diets have various health effects. For example, plant-based diets higher in whole grains, fruits, vegetables, nuts, legumes, vegetable oils, and tea/coffee are associated with reduced chronic disease risk, while plant-based diets high in fruit juices, sugarsweetened beverages, refined grains, potatoes, and sweets/desserts are associated with an increased risk of chronic disease

Yet little research has been conducted to determine the environmental impacts, such as greenhouse gas emissions, use of high-quality cropland, nitrogen from fertilizer, and irrigation water, of these dietary approaches. Using data from the Nurses' Health Study II, the researchers analyzed the food intakes of more than 65,000 qualifying participants, and examined their diets' associations with health outcomes, including relative risks of cardiovascular disease, and with

environmental impacts. To differentiate plant-based dietary patterns, the researchers characterized participants' diets using various dietary indices, including the Healthy and Unhealthy Plant-based Diet Indices. Higher scores on the unhealthy plantbased diet index indicated higher consumption of refined grains, sugary drinks, fruit juice, potatoes, and sweets/desserts; while higher scores on the healthy plant-based diet index indicated higher consumption of vegetables, fruits, whole grains, nuts, legumes, vegetable oils, and tea/coffee.

Participants who consumed healthy plantbased diets had lower cardiovascular disease risk, and those diets had lower greenhouse gas emissions and use of cropland, irrigation water, and nitrogenous fertilizer than diets that were higher in unhealthy plant-based and animalbased foods. Participants who ate unhealthy

plant-based diets experienced a higher risk of cardiovascular disease, and their diets required more cropland and fertilizer than diets that were higher in healthy plant-based and animal foods. The findings also reinforced earlier studies showing that diets higher in animal-based foods, especially red and processed meat, have greater adverse environmental impacts than plant-based

"Because human health ultimately depends upon planetary health, future U.S. dietary guidelines should include nuanced consideration of environmental sustainability and recognize that not all plant-based diets confer the same health and environmental benefits," said Daniel Wang, assistant professor in the Department of Nutrition at Harvard Chan School, the Channing Division of Network Medicine at Brigham and Women's Hospital and Harvard Medical School and co-author of the study.

Low turnout in HP's largest district Kangra

The process of voting for the assembly elections in district Kangra was completed peacefully. District Election Officer and Deputy Commissioner Kangra Dr. Nipun Jindal said that 71.68 percent polling was recorded for 15 assembly seats in the district. In the total voting percentage of women was 76.09 and the voting percentage of men was 67.31. Of the 13,12,774 voters in the district, 9,40,976 took part in polling on Saturday, including 4,96,965 women and 4,44,008 men. Apart from this, 3 voters of third gender exercised their franchise. Their demand is for the stoppages of the train that used to stop here before Covid 19. People are facing issues as the ones who are regular passengers, they are



now and they have to spend almost 300 rs per day," Hitesh Nayak, an adult said while talking to ANI. A college student Prachi Patel said that she was facing problems in her study due to the issue as she had to leave one of her lectures in the morning. Member of the Zonal Railway Users Consultative Committee (ZRUCC) Chhotubhai Patil said that no concerned people are responding to the issue. "A local passenger train used to stop here since 1966 but it was stopped due

to the Covid pandemic. After it restarted, it does not stop here at our station. People from at least 19 villages do up-down from here for their jobs and daily based earnings," said Chhotubhai Patil. "They are facing issues. We are not demanding the new one. We just want the same train, but still, the local administrators or representatives responding," he further said. Chhotubhai Patil said that the villagers have decided to send the Electronic Voting Machine (EVM) with no vote. "We have

decided to boycott this assembly election and we will send the EVM back all empty," he added.

The elections will be held in

two phases on December 1 and 5. The counting of votes will take place on December 8, which coincides with Himachal Pradesh's result date. BJP is in power in the state for the last 27 years and is considered as BJP bastion. However, the Congress is also hoping to put its best electoral foot forward to unseat the BJP government. The ruling party is seeking its seventh, straight term in power in the ensuing state polls. The state has been a BJP stronghold for a long and the party has set its sights on returning to power with a handsome majority this time as well. However, it faces a stiff electoral challenge from the Arvind Kejriwal-led Aam Aadmi Party (AAP), which has named Isudan Gadhvi as its chief ministerial candidate. BJP on Saturday released the second list of six candidates for the upcoming Gujarat Assembly elections. In the second list of six candidates, BJP has given tickets



Punjab makes mandatory to use 20% of straw as fuel for brick kilns

SHASHI PAL JAIN CHANDIGARH, NOV 13

The State Government, which is making continuous efforts in the management of paddy straw, has taken an important step in this direction and has decided to make it mandatory for brick kilns across the state to use 20 percent of straw as fuel.

It was disclosed by Environment, Science and Technology Minister Gurmeet Singh Meet Hayer in a press communique here today. He said that under the guidelines of Chief Minister Bhagwant Mann, the State Government has issued a notification that 20 percent of

straw pellets for brick kilns must be used as fuel. He also said that brick kiln owners have been given six months to prepare for this new management and action will be taken against those who do not implement these instructions after May 1, 2023. Meet Hayer said that in situ and ex situ works are being done by the State Government to help farmers in stubble management and deal with the problem of pollution caused by stubble burning. The farmers of Punjab have been provided 1.25 lakh machines on subsidy for in situ stubble management whereas under ex situ, industries are being encouraged to use stubble as



fuel. Efforts are being made to generate CNG, electricity and other energy sources from straw, said the Minister. Meet Hayer said that under the new decision, 20 percent use of straw as fuel in brick kilns will give a big boost to straw management and farmers will also get financial help by

selling straw. He further said that the Department of Environment and Science and Technology will provide all technical assistance to the brick kilns. Besides, all Deputy Commissioners have also been asked to follow these instructions under the notification issued in this regard.

Mizoram failed in their second innings against the deadly spell from Paras (5/6) which included a hatrick also. The visitors were bundled out for mere 62 runs. Chandigarh's next match is scheduled against Tamil Nadu at their home ground from November 19.



Stokes powers England to second title win, beat Pak by 5 wickets

MELBOURNE, NOV 13

Top performances from Sam Curran and Ben Stokes powered England to their second ICC T20 World Cup title after 2010, as they defeated Pakistan by five wickets in a gripping low-scoring final at the Melbourne Cricket Ground (MCG) on Sunday.

England delivered a fantastic performance with the ball, reducing Pakistan to 137/8. Sam Curran (3/12) lead the English batting attack. Chasing 138, England was reduced to 45/3 before powerplay, but Stokes (52*) delivered in a big match once again to take his side to a victory.

Chasing 138, England lost opener Alex Hales in the first over itself for just one run after Shaheen Afridi sent a delivery crashing through his gates. England was 7/1 in one over. Phil Salt joined skipper Jos Buttler. The duo attacked young pacer Naseem Shah, smashing him for three fours, with the captain hitting two. Just when it seemed that the duo was building a partnership, Haris Rauf intervened to send back Salt for just 10 off nine balls. England was 32/2 in 3.3 overs.

All-rounder Ben Stokes came to bat next. Rauf got his second wicket of the match as he dismissed the skipper Buttler for 26 off 17 balls. England was 45/3 in 5.3 overs.

At the end of powerplay in six overs, England was 49/3, with Harry Brook (4*) joining Stokes (1*). The duo helped England reach halfway through their innings without any damage. At the end of 10 overs, England was at 77/3, with Brook (14*) and Stokes (17*). Stokes-Brook were bringing England

back into the game, one run at a time. But their stand was cut short at 39 runs by spinner Shadab Khan, who dismissed Brook for 20 off 23 balls. Shaheen took a brilliant catch at long-off. England was 84/4 in 12.3 overs.

Moeen Ali joined Stokes to carry on with the chase. At the end of 15 overs, England was 97/4, with Stokes (28*) and Ali (3*).

England touched the 100-run mark in 15.4 overs. England needed 38 in 26 balls. Stokes relieved some pressure by smashing a four over covers and a six over long-off to bring down the equation to 28 needed in 24

Moeen smashed pacer Mohammad Wasim for two boundaries in the first two balls of next over, bringing down the deficit to 20 runs in 22 balls. He also hit a boundary on the final ball, leaving England to chase 12

The 48-run stand between Ali and Stokes came to an end after Wasim dislodged the former's stumps. The left-hander's short, but valuable cameo was over at 19 runs in 13

England needed 6 in 10 balls and five of their batters were back in the hut for 132. Stokes brought his first half-century in

T20I cricket with a four in 47 balls. Scores were levelled. Stokes brought the winning runs,

England finished the innings at 138/5 in 19 overs, with Stokes unbeaten at 52* off 49 balls and Liam Livingstone at 1*. Rauf (2/23) was the pick of the bowlers

for Pakistan. Shaheen, Wasim and Shadab Earlier, Sam Curran, Chris Jordan and Adil Rashid delivered stunning spells to restrict Pakistan to 137/8 in the final of the ongoing ICC T20 World Cup at the iconic Melbourne Cricket Ground (MCG) on

Sam Curran delivered stunning spell and bagged three while Chris Jordan and Adil Rashid took two wickets each respectively. Shan Masood scored the highest runs for Pakistan with 38 while skipper Babar Azam scored 32.

Put to bat first, openers Babar Azam and Mohammad Rizwan opened Pakistan's tally in the first inning by bagging 8 runs in the very first over of all-rounder Ben Stokes. Stokes delivered a no-ball on the very first delivery of the innings as the all-rounder swung it away and Rizwan covered for it as he defended to mid-off.

ICC announces hosts of U19 global events until 2027

DUBAI: The International Cricket Council (ICC) Board has approved Sri Lanka, Malaysia and Thailand. Zimbabwe and Namibia and Bangladesh and Nepal as the host countries of the ICC U19 events from 2024-2027. The ICC U19 Men's Cricket World Cup 2024 will be hosted by Sri Lanka whilst the 2026 edition will be staged in Zimbabwe and

Namibia. The ICC U19 Women's T20 World Cup 2025 will be held in Malaysia and Thailand, and the 2027 U19 Women's event will be jointly hosted by Bangladesh and Nepal as announced by ICC. The hosts were selected via a competitive bidding process overseen by a Board subcommittee chaired by Martin Snedden. The ICC Board accepted the recommendations of the committee who conducted a thorough review of each bid along with ICC management. The qualification pathway for the 10team ICC Women's T20 World Cup 2024 was approved. Eight teams will qualify for the event automatically comprising the top three teams from each group from the ICC Women's T20 World Cup 2023.

Maxwell out for extended period after breaking his leg in freak accident

MELBOURNE, NOV 13

Australia all-rounder Glenn Maxwell has been ruled out of cricket for an extended period after suffering a broken leg in "a freak accident" at a birthday party in Melbourne on Saturday.

The all-rounder has been ruled out of the upcoming ODI series against England beginning this week and will undergo a lengthy rehabilitation after fracturing his left fibula on Saturday.

He slipped while running in

a backvard with a friend and his leg became trapped. The injury means Maxwell won't have the chance to make a rare Sheffield Shield appearance in early December or feature for Australia A against South

"Glenn is in good spirits It was an unfortunate accident and we feel for Glenn in the circumstances given he was in great touch in his last few games," Australia's selection chief George Bailey said in an official statement on Sunday.

"Glenn is a critical part of our white ball structure and we



will continue to support him through his recovery and rehabilitation," he added.

Sean Abbott has been named as the replacement for Maxwell in the squad for the ODI series.

Earlier Jonny Bairstow of England was sidelined for the rest of the year earlier after slipping while playing golf and breaking his ankle severely. Josh Inglis, the wicketkeeper for Australia, was injured severely while playing golf the day before the T20 World Cup and was forced to skip it.
