Three held in Odisha for siphoning govt subsidy of Rs 12 crore

BHUBANESWAR: The **Economic Offences Wing** (EOW) of Odisha crime branch has arrested three persons for allegedly misappropriating government subsidy to the tune of over Rs 12 crore meant for supply of agricultural equipment to farmers, a police official said on Saturday.

The arrested accused are Pradeep Kumar Acharya, the MD of Annapurna Agro International Pvt. Ltd., Prabha Ranjan Dash, proprietor of Dash Traders & Agro Agency, and Shaik Fayaz, proprietor of Shaik Fayaz They were arrested from Bhubaneswar, Daspalla in Nayagarh district and Berhampur and were presented at a local court in Bhubaneswar on Saturday, an EOW official said. The three accused persons allegedly misappropriated government subsidy meant for the farmers/beneficiaries amounting to at least Rs 12 crore by manufacturing and using forged documents/email IDs, etc.

During investigation, it was revealed that Pradeep Acharya's firm is registered under direct benefit transfer (DBT) scheme for supplying post-harvest machines power-driven equipment and rotavator etc. Acharya in conspiracy with the two other accused allegedly uploaded a series of fake documents in respect of supply/sale of 381 agro equipment to equal num-ber of farmers between 2016-17 and 2019-20.

Andhra Pradesh to introduce semester system in schools

AMARAVATI: All govern-Andhra Pradesh will have a two-semester system from the next academic year, it was announced Saturday.

The state government has issued an order introducing the two-semester system in all government schools from Class 1 to 9 from the next academic year and for Class 10 from 2024-25.

HP govt issues show-cause notices to two cement manufacturers for shutting their operations AGENCY HIMACHAL PRADESH, DEC

Himachal Pradesh government has issued show-cause notices to two private cement manufacturers for shutting down their operations in the state without prior intima-

The show-cause notices issued in the name of Ambuja Cement Ltd in Solan district and ACC Cement Lid, Gagal Cement Works in Bilaspur (H.P.) say, "The firms have stopped their operations without any prior notice, thus putting a question mark on the livelihood of thousands of stakeholders who are engaged in transportation and other allied activities.

A meeting was held under the chairmanship of the Chief Secretary, Government of Himachal Pradesh to assess the situation and on the basis of which the state government took cognizance and issued notices to the firms.

"It is indeed alarming that you have not taken the state government or its functionaries into confidence before taking such a major decision involving the lives and livelihoods of so many stakeholders. Moreover, you have not even tried to approach or exhaust



nels available with the state machinery in order to resolve whatconcerns, grievances, or issues that they might have, the notice issued by the director of industries to the firms on Friday.

"It is to our disbelief that even the local administration was clueless about your drastic steps and if not for the alertness of our law and order machinery, the situation could have easily deteriorated, for

which you would have been solely responsible," the notice says.

You are aware that precious land for the plant, mining lease, and other required infrastructure have all been granted to you by the government in order to commission your project and facilitate further operations of the same. It is also a fact that thousands of peoples have also lost their land in either the leased area or plant site thereby permanently affecting their livelihood

Temperature rises above normal in Himachal, absence of snowfall disappoints tourists

The temperature in Himachal Pradesh has risen above normal by 3 to 4 degrees Celsius. The tourists and locals who were expecting snowfall and cold conditions are disappointed. Tourists from different parts of the country come to the state capital Shimla to experience fresh snowfall. However, only sunny days are being experienced in the 'Queen of Hills'.

Nevertheless, tourists coming from other parts of the country are still enjoying the pleasant weather conditions.

'We were expecting it to be cold. We thought that we'll get to see snowfall. We have come from Delhi. I was expecting snow here but the weather conditions are clear. It is a very sunny day out here. The temperature is higher than what we have in Delhi. I thought it would be very cold but it is warm. I am just wearing a sweater and no jacket. It feels good to be here but disappointed by the fact that we could not see snowfall. It could be because of the changing weather conditions, the climate change, and the increase in the number of vehicles," said a

"We expect that there will be snowfall during Christmas. This year, the temperature in Shimla and Patiala is exactly the same. I have taken off my jacket. We have been observing that the weather is changing here," said Ravinder Rishi, a tourist from

"It is a very beautiful and clean atmosphere, here in Shimla. You cannot predict the weather here, it's very unpredictable. We are going to stay here till Christmas. We will definitely get to see snow here," said another tourist.

The Indian meteorological department has forecasted clear weather during the next few days. As per the forecast from the local weather department, the weather will be clear till Decem-

However, a warning has been issued regarding a cold wave in the Una region. Fog conditions have also been forecasted in Bilaspur Mandi Hamirpur and Una districts of the state. In the days to come, the temperatures are expected to remain the same.

Delhi acid attack: Accused sent to 14-day judicial custody

A Delhi court on Saturday sent three accused allegedly involved in an acid attack on Wednesday on a 17-year-old school girl to 14 days of judicial custody.

The three individuals were presented in the court after their police custody ended on Saturday. They were arrested on December 14 after the incident had taken place earlier in the day.

They were presented before a Metropolitan Magistrate in Dwarka court, who Harshit Aggarwal a.k.a. Hon- han, the Deputy Commis-

A day after the shocking incident of an acid attack on a 17-year-old schoolgirl, the Delhi Police on Thursday also issued notice to Flipkart, from where the accused had bought the acid.

The acid has been procured online through Flipkart. A notice has been sent to Flipkart to provide information regarding the seller and the particular transaction. They have also been asked regarding compliance of regulations related to sale of sioner of Police (Dwarka).

The sale of acid is banned in the market but the accused Sachin had bought it online from the e-commerce platform.

The 17-year-old school girl was attacked with acid on Wednesday morning near Dwarka Mor while she was on her way to school along with her sister. Arora, along with Harshit and Virender had planned and hatched the conspiracy a few days ago to throw acid on the girl after their friendship ended in September this year, an official said. All the three accused are where the girl resides.

ADGP Law & Order hands over Rs. 2 cr cheques to family of slain constable Mandeep Singh

On the directions of Punjab Chief Minister Bhagwant Mann, Additional Director General of Police (ADGP) Law and Order Arpit Shukla on Saturday handed over two cheques of Rs 2 crores (Rs 1 crore each) to the family of slain Punjab Police Constable Mandeep Singh, who attained martyrdom in line of duty.

A 2013-batch Constable Mandeep Singh, 32, a resident of village Kotli Gajran in Shahkot, Jalandhar, was posted as a gunman with a cloth merchant deceased Bhupinder Singh alias Timmy. In a brave act, he got martyred suffering bullet injuries during exchange of fire with the assailants in Nakodar on December 7,

Following his supreme sacrifice, CM Bhagwant Mann had announced Rs 2 crore to the family of martyr as a mark of respect. The Rs 2 crores amount includes Rs 1 crore as ex-gratia by the state government whereas another payment of insurance cover worth Rs 1 crore will be made by the HDFC bank.

The ADGP accompanied by Inspector General of Police (IGP) Jalandhar Range Gursharan Singh Sandhu was here to attend the Antim

Ardas Bhog Ceremony of the Martyr held at Gurdwara Singh Sabha Sahib

in village Kotli Gajran, Shahkot. ADGP Arpit Shukla, while addressing the media, said that he has handed over Rs 1 crore cheque on the behalf of the State Government, while, another cheque of Rs 1 crore has been given to the martyr family under welfare policy of Punjab Police personnel on behalf of Director General Police (DGP) Punjab Gaurav Yaday and HDFC Bank.

He said that due to his supreme sacrifice, the name of Mandeep Singh has also been recommended for the Presidential Gallantry (posthumously).

AAP national council meeting to be held tomorrow, first after becoming 'national party' **NEW DELHI, DECEMBER 17**

Aam Adami Party (AAP) convenor and Delhi Chief Minister Arvind Kejriwal will chair the National Council meeting of the party scheduled to be held on Sunday at Calista Resort in Ka-The leaders of all the states including AAP's representatives from across the country will

participate in this meeting to discuss the strategies and party's preparations for the upcoming Lok Sabha elections. This would be the first such meeting after Kejriwal claimed that the party has now become a "national party legally" after the Gujarat Assembly elections, the party official said.

Kejriwal earlier had claimed that his 10-year-old party has become a "national party" after AAP got almost 13 per cent votes in the Gujarat Assembly election. However, the party won the high-stakes battle for control over the Delhi Municipal Corporation winning 134 of the total 250 wards in the national capital's civic body polls, uproot-

ing 15-year rule by the Bharatiya Janata Party (BJP). The first meeting of the newly elected Corporation will be held on January 6 as the Delhi Lt Governor VK Saxena on Thursday approved the proposal to convene the meeting. The move came as per the powers vested in the Lt Governor VK Saxena vide Section 73 of the Delhi Municipal Corporation Act, 1957.

Yogi Adityanath assures to resolve issues of Sikhs in UP

LUCKNOW, DEC 17

Uttar Pradesh Chief Minister Yogi Adityanath on Saturday assured to resolve all the pending issues of the Sikh community brought to his notice by a Shiromani Akali Dal-Shiromani Gurdwara Parbandhak Committee (SGPC) delegation, stating that no Sikh farmer will be victimised.

He also promised to withdraw all the pending cases against Sikhs with regard to the Saharanpur gurdwara clash in 2014.

The assurance was given by the Chief Minister to a high-level delegation led by SAD President Sukhbir Singh Badal. Senior SAD leader Prem Singh Chandumajra and SGPC general secretary Gurcharan Singh Grewal were also part of the delega-

Badal told the media that the meeting was held in a positive atmosphere with relevant officials of different departments to get direct feedback about all the issues concerning the welfare of

Badal thanked Adityanath for taking special interest to resolve the pending cases and asserted that this would go a long way in bolstering the morale of the Sikh community in Uttar Pradesh.

Giving details, Badal said with the intervention of Adityanath, displacement of Sikhs from lands being cultivated by them had been prevented in 2020 on the request of a SAD delegation.

The UP Chief Minister, after giving a patient hearing, announced that he would not allow any Sikh farmer or Punjabi to be victimised in Uttar Pradesh. He agreed with the SAD President that

Sikh farmers had paid with their blood and

sweat to make the lands they were tilling fertile. The Chief Minister asked minister of state Baldev Singh Aulakh to go through all the cases so that they could be resolved amicably. The cases include eviction notices issued to Sikh farmers in Moradabad, Bareilly and Lucknow circles.

The delegation also apprised the Chief Minister that some cases related to a clash between two communities over land belonging to a gurdwara in Saharanpur in 2014 still remain unresolved.

It said following the clash, mediation was effected between the leadcommunities and it was

decided that members of both communities would withdraw counter cases registered against each other.

The delegation said that while some cases were withdrawn, few cases persisted

and solicited the intervention of the Chief Minister to resolve the issue, to which Adityanath agreed.

The delegation also apprised the Chief Minister about the Pilibhit fake encounter case of 1991 in which 10 Sikhs were killed after PAC personnel stopped a pilgrim bus and separated the male members from their families and stage three separate 'encounters'. It said the Allahabad High Court had recently set aside the life imprisonment awarded to 43 PAC personnel in the case and sentenced them to seven-year terms. The delegation said the Sikh community felt that exemplary punishment should be awarded in the case as innocents were killed by terming them as terrorists. It urged the Uttar Pardesh government to file a review petition in the case in the Supreme Court. The Chief Minister assured to look into the matter sympathetically, saying that justice will be done in the

Govt must not bait judges, move to evolve system first

f the statements of Union law minister Kiren Rijiju in Parliament on the Supreme Court hearing bail peti-Lations and on the pendency of cases in the country, reflect the government's approach and attitude to the judi-

ciary, then it is extremely unfortunate.

The minister, while moving the New Delhi International Arbitration Centre (Amendment) Bill, told the Rajya Sabha on Wednesday that if the Supreme Court starts hearing bail applications and all "frivolous public interest litigations", it will definitely place a lot of extra bur-den on it, because "by and large" it is "treated as a constitutional court". On the delays in the appointments to the high courts and the Supreme Court, the minister told the Lok Sabha on Thursday that the issue of vacancies and appointments in the higher judiciary would continue to linger till the time a new system is created for it.

It cannot be that the Union law minister is unaware of the existence of Article 21 in the Constitution which mandates that "no person shall be deprived of his life or personal liberty except according to procedure established by law". The entire edifice of the Constitution is built as a guarantee of the citizen against the State, whether it is benign or not. Article 21 forms the cornerstone of the structure, without which the entire existence of it will become futile. If the State can incarcerate people at will, misusing and abusing the law, and if the judiciary is blissfully looking the other way, then such a country should stop calling itself a democracy, and a constitutional democracy at that.

The law minister of India must realise that the Supreme Court and the high courts will cease to be constitutional courts not when they hear bail petitions but when they stop doing so. They are doing their job, period. The government may have its own idea about how courts should approach bail pleas presented against its agencies but the law minister articulating them in public is a serious breach of propriety and the principle of separation of powers.

The minister's statement on pendency of cases makes it clear that the large number of vacancies on the bench contributes to it and that the government knows the way out. His explanation that the government has currently limited powers to fill the vacancies in courts does not wash — the Supreme Court has time and again complained about how the government delays appointments and stops eminent people from joining the bench.

The government is peeved by the Supreme Court striking down the National Judicial Appointments Commission (NJAC), and rightfully so.

Tackle toxic air now: It's ruining our lives, future

There is a new twist in the tale of the legendary Delhi-Mumbai rivalry. Both cities find pointscoring politically nourishing, even entertaining, as an astute foreign observer once noted. As a resident of Delhi for over three decades, I must say, I thoroughly enjoy the jousts over the rivalry which dwarfs other inter-city divides in the country. But even I was taken aback by recent news reports that Mumbai had displaced my city, even if temporarily, from the dubi-ous perch of being the city with the foulest air.

Mumbai, India's financial capital, which lies on the coast of the Arabian Sea, is in the news for its steadily plummeting air quality; its overall air quality index (AQI) crossed 300, considered "very poor", earlier this month. What instantly made news was that on some days, some parts of Mumbai had air more toxic than Delhi.

Toxic air is an everyday reality for residents of Delhi. In winters, things get worse, and the AQI becomes an everyday talking point if you live in Delhi, or anywhere in the National Capital Region (NCR) or parts of northern India. We have come to a stage when we celebrate when the AQI improves a little and the quality of air is classified as "poor" instead



And now, Mumbai has gone and beaten us on the toxic air stakes. Even Kolkata, where I was born, where I spent many of my formative years, and where I am right now, soaking in the World Cup football fever, is also in the news for its bad air. Newspapers reported that Kolkata's average AQI was worse than Delhi on two days in late November.

Clearly, air pollution in India is restricted neither to Delhi, nor to winters. More affluent Indians are now seeking to protect themselves by installing air purifiers, remaining indoors in more "protected air" and venturing outdoors with masks on. This helps, but only partially because air purifiers cost money and to purify each room cost a lot. Moreover, few of

us can stay confined to airpurified premises all the time. What do the rest do? Children are particularly vulnerable. Also, the elderly.

Here is a snapshot of the AQI from some of India's small towns, picked out at random from the Centre for Pollution Control Board (CPCB) portal.

At 4 pm on December 13, the AQI at Begusarai in Bihar was 457, considered severe. The corresponding figure for Howrah in West Bengal was 318 (very poor). The AQI for Samastipur, also in Bihar, was 437 (severe).

Delhi's toxic air makes news because Delhi is the national capital. It is also the city with many air quality monitoring stations, more than most megacities in India. Residents of many cities are breathing foul air --

which is making them ill. But they are unaware of how bad the air is, because there are not enough monitoring sta-tions. It is also glaringly obvious that apart from killing us slowly, toxic air is taking a huge toll on India's economy.

According to a 2021 report by Dalberg Advisers in partnership with Clean Air Fund and the Confederation of Indian Industry (CII), air pollution costs Indian business about \$95 billion every fiscal air, around three per cent of India's total GDP.

"Conventional wisdom," the report says, "considers air pollution an unavoidable byproduct of economic growth, thus limiting the intensity of response to it. In existing literature and publications, GDP per capita and growth rate are often linked to emissions levels, one predicting

the other. This has framed an understanding, with many businesses, that growth and good air quality are always in conflict, which has led to an entrenched perception of environmental regulations as being a cost that holds back companies." However, as the report's findings made clear, toxic air shaves off economic growth. It leads to lower labour productivity, lower consumer footfall, premature mortality, lower asset productivity, increased health expenses and welfare losses. "Out of these, employee productivity, consumer footfall and premature mortality impact businesses directly,' notes the report.

Focusing solely on the toxic air in Delhi diverts attention from other cities and huge swathes of the country suffering from acute air pollution. And we do not know how bad it really is.

"In India, we estimate that we require around 4,000 continuous monitoring stations to represent the air pollution problem spatially and temporally -- 2,800 in urban areas and 1,200 in rural areas. Currently, data when available comes from around 600plus manual stations and less than 100 continuous monitoring stations," Navroz Dubash of the Centre for Policy Research (CPR) pointed out in a commentary piece in December 2017. That number has gone up to over 800 currently. Other experts say India needs at least 1,600 air quali-ty monitors, though 4,000 will be an ideal number.

"It is very important to understand that air pollution is a regional problem. We need to focus on regions in the country, where people are exposed to unsafe levels of pollution, and there are no monitors to determine how much that is," stressed Mr Dubash.

The bottomline -- while air pollution shortens lives around the world, its most severe impacts are being felt in South Asia, Southeast Asia, and sub-Saharan Africa. India has had a National Clean Air Programme since January 2019. It has failed to have any impact so far.

What do we need? First, more air quality monitoring stations so that everyone knows how bad the problem

Second, to heed the studies that apportion the pollution sources in various cities and regions -- unchecked or poorly-checked pollution from factory chimneys, vehicles whose owners do not follow rules and a far more effective control of dust from the myriad sites where homes, offices, roads, bridges and so on are being

cademics in India is very competitive. There is a large youthful **L**population vying for limited professional education. Performance in school only plays a part; many professions have their own entrance exams as well as other criteria like a statement of purpose and interviews for admission. This places families under tremendous pressure, both emotionally and financial-

In school, students are pushed to perform (sometimes unrealistically) as the institution's reputation is at stake. At home, anxious parents enrol them in tuition and coaching classes. The games periods in school are usurped for "extra classes" in mathematics or science subjects. Children may be asked to stay an hour after school for extra classes. Sick leave is a no-no. An unwell child cannot concentrate and study and may pass the contagious illness to the rest of their

classmates. The coaching centres usurp weekends to train children for competitive exams. Eventually, they need to take out advertisements to showcase "top-

In this scenario, everyone is a loser. The child's health suffers. He or she needs 8-10 hours of sleep per night for the brain to grow and develop well but does not get this. Usually, children are up till 11pm doing school and tuition homework. Without adequate sleep, the brain not only does not develop properly, but it is also unable to learn, retain and process new information quickly.

Physically, either the child is overweight from junk food or thin and malnourished from not eating enough. The appetite is poor. Immunity develops with good physical activity. As this is lacking, illness is frequent; recovery is slow. Rest, required for rapid recovery, is denied as the school demands attendance.

Gently down the stream

Rowing machines are having a moment. Long the ugly ducklings of the gym, tucked away in forgotten corners, the workout devices are getting a makeover - just like indoor cycling machines did a decade ago.

To dedicated rowers, this come as a surprise. Rowing is a total body workout that targets the muscles in your legs, back, core and arms. It's also great for your cardiovascular system because it challenges the heart in multiple ways.

But there is a learning curve when it comes to rowing. Proper form is critical not only for avoiding injury, but for developing a powerful, efficient stroke and achieving a good workout.

The most important thing to keep in mind about rowing is that while it looks like you're yanking the handle (or oars) with your arms, most of the power comes from your legs until the very end. "Rowing is a pushing sport, not necessarily a pulling sport," said Neil Bergenroth, a rowing coach in Tulsa, Oklahoma,

The movement is typically broken down into four steps. The Catch

In the catch position, the

your body, such as your calves, hamstrings and glutes, said Casey Galvanek, head coach of the US Rowing Association's Junior National Team. This helps you to create more power by using more muscles, he said.

Once you've pushed about halfway back, with your knees bent to roughly 90 degrees, start to lean back, pivoting through your hips. You should feel your lats — the major muscles in your back — start to engage as you hold onto the handle. Lastly, drive your elbows back to pull the handle into your chest.

The police had informed the family here that Saju had strangled his wife and the children. Centre should take over rationing system in national capital: Delhi BJP

AGENCY NEW DELHI, DEC 17

The Delhi BJP on Saturday urged the Centre to either take over the ration system or transfer the subsidy issued by the Centre to the bank accounts of the consumers as the Delhi government has "failed" to provide ration to the poor. Accusing the Kejriwal-led government of depriving 72.78 lakh ration cardholders of the national capital from the ration in November and December, Delhi Pradesh BJP Working President Virendra Sachdeva and Leader of Opposition Ramvir Singh Bidhuri said the rationing system in the national capital has come to a complete standstill.

The Central Government released 8,000 tonnes of rice and 11,900 tonnes of wheat for half year from April to September this year, but the Delhi government could not distribute even this, they alleged.

The reason is that more than 34,000 quintals of rice from Mayapuri, Okhla and Pusa

Liquor prices in Kerala goes up by Rs 20



Liquor prices in Kerala were hiked from Saturday after the state cabinet approved a 4 per cent increase in the general sales tax, which came into effect after state Governor Arif Mohammed Khan gave his assent to pass the Kerala General Sales Tax (Amendment) Bill.

As a result of the increase, the price of brands of various Indian Made Foreign Liquor (IMFL) brands has gone up by Rs 10 to Rs 20, while the price of wine and beer has been raised by 2 per cent.

The IMFL manufacturers

State Beverages Corporation (KSBC) -- the sole wholesaler of liquor in Kerala -- to increase the prices in the wake of steep rates of extra neutral alcohol.

The data in the past seven years shows that while in 2015-16 the total sales of KSBC was Rs 11,577 crore, it reached Rs 14,707 crore in 2019-20 but decreased to Rs 13,212 crore in the next fiscal when the state was reeling under Covid-19 pandemic. However, in 2021-22 the total sales of KSBC again rose to Rs 14,576 crore and according to the data for the first six months in the present fiscal, it has touched Rs 8,460 crore.

IISc research team develops germ-destroying air filters

NEW DELHI, DEC 17

A newly-developed air filter supported by special grants from and Engineering Research Board (SERB) can deactivate the germs, 'selfcleaning' them out of the system, using ingredients commonly found in green tea. A research team led by Suryasarathi Bose and Kaushik Chatterjee at the Indian Institute of Science (IISc), Bangalore, developed germdestroying air filters that can inactivate germs ingredients like polyphenols and polycationic polymers commonly found in green tea. These 'green' ingredients rupture the microbes through sitespecific binding. Impure air might make our life shorter to the extent that Indians lose 5-10 years of their lives because of airborne contaminants leading to respiratory diseases, adversely affecting physical health as well as mental health, according to a report by University of Chicago. The research was supported by special grants from SERB during Covid-19 SERBchallenging pandemic Technology Translation Awards

patent has been filed on this. Over continuous usage, the existing air filters become a breeding ground for captured germs. The growth of these germs clog the pores of the filter, reducing the life of the filters Resuspension of these germs can infect people in the vicinity. The novel anti-microbial air filters were tested at the National Accreditation Board for Testing and Calibration Laboratories and were found to deactivate SARS CoV-2 (delta variant) with an efficiency of 99.24 per cent. This technology was transferred to AiRTH, a startup that is replacing the existing germ-growing air filters with germ-destroying air filters for commercialisation said the Ministry of Science and Technology on Saturday. As this innovation holds promise to develop antimicrobial filters that can prevent endemics caused by air-borne pathogens, a patent was granted in 2022. These novel antimicrobial filters in our ACs, central ducts and air purifiers can play a crucial role in our fight against air pollution and mitigate the spread of air-borne pathogens

The arrested have been identified as Congress leader Shafiq Ahmad and his wife Syed Munibunnisa. Both have been included in the rowdy sheeters' list by the police, he said. The accused couple, along with some others, had threatened the officers attached to the Karnataka Road Transport Corporation (KSRTC) with a machete for getting their stalls vacated from the premises of Sathagalli bus terminal. The action was taken as per the court order as the couple failed to pay rent for two years. The incident had taken place on



December 10. The couple with other women had abused the officers and threatened the staff by wielding the machete. When it turned into a controversy, they went underground. KSRTC Divisional Transport Officer Mari Gowda had complained about this matter to the Udayagiri police in Mysuru. The photos and videos of the incident went viral. The couple were traced in a village of neighboring Kodagu district. A manhunt has been launched for other three accused in connection with the case.

40 child deaths from measles between November and December, 10, 416 cases: Govt

NEW DELHI: The recent upsurge of measles cases in the country led to 40 child deaths, of which three were in Haryana and the highest—13—in Maharashtra

Giving information on the sudden rise in measles cases through November and December this year, the government on Friday informed Parliament that 10,416 measles cases were seen between November 2022 until December 12 and 40 children died.

The upsurge was witnessed in Bihar. Gujarat, Haryana, Kerala, Jharkhand and Maharashtra. Minister of State for Health Bharati

Pawar said taking note of certain districts and cities of Maharashtra,

With Gujarat and Kerala witnessing the upsurge, Union Ministry of Health deployed multi-disciplinary Central teams comprising of public health specialists, paediatricians and microbiologists to assess the situation and provide technical support to the States. Following the surge, the Centre

asked all vulnerable areas showing a recent increase in measles cases to consider an additional dose of the MR vaccine for all children aged nine

months to 5 years. This dose is over and above the primary vaccination schedule of the first dose which is given at 9 to 12 months and the second dose which is given at 16 to 24 months.

The government said that one dose of Measles rubella vaccine should be administered to all children aged six months and up to less than nine months in those areas where measles cases in the age group of less than nine months or above 10 pc of the total measles cases. The disease is known to be fatal among children with malnourishment. As per the WHO and UNICEF estimates of immunisation coverage the first dose coverage of measles and rubella-containing vaccine is 89% and that of the second dose is

82% in India.

28 pc GST on online games where winning depends on certain outcome: CBIC chief

NEW DELHI, DEC 17

Central Board of Indirect Taxes chief Vivek Johri on Saturday said online games where winning is dependent on a certain outcome would attract 28 per cent GST on the full bet value.

Though the report of the Group of Ministers (GoM) on online gaming did not come up for discussion at the GST Council, the department would go by the view that 28 per cent GST is payable on full bet value put in by a player, and not net of margins. The comments assume significance as the Gameskraft Technology Pvt Ltd (GTPL) GST evasion case is still in the court.

Directorate General of GST Intelligence (DGGI) in September issued a show cause notice to Bengaluru-based online gaming company Gameskraft Technology Pvt Ltd (GTPL), for not Goods and Services Tax (GST) to the tune of Rs 21,000 crore.

Asked what would be the position of the Central Board of Indirect Taxes (CBIC) since the Council has not decided yet on the GoM report, Johri said the department's view is that 28 per cent GST is payable on actionable claims arising out of betting or gambling and the tax is to be payable on full value, not net of margins. "The gaming activity is



considered as gambling because the winning is dependent on a certain outcome," Johri said. The report of the GoM could not come up for discussions in the GST Council since it came in just two days ahead of the Council meeting and hence could not be circulated to the states. Usually, GST Council secretariat gives notice to members in the GST Council before tabling any agenda. Meghalava Chief Minister Conrad Sangma chaired Group of Ministers (GoM) had on Thursday submitted its report to Finance Minister Nirmala Sitharaman. The GoM, in its last meeting in November, had agreed on a 28 per cent GST on online gaming casinos and horse racing. However, in absence of consensus on whether the tax should be levied on only the fees charged by the portal or the entire consideration, including the bet amount, received from participants, the GoM had decided to refer all suggestions to the GST Council for a final decision. Briefing reporter after the GST Council meeting on Saturday, Finance Minister Nirmala Sitharaman said the GoM report would be "discussed threadbare" when the Council takes it up for discussion.

The Defence Ministry mentioned this in a vear-end review.



Referring to the situation along the LoC (with Pakistan), it said the situation has been relatively peaceful with both Indian and Pakistani armies observing ceasefire understanding since February last year. "As compared to 4,645 ceasefire violations during its peak in 2020, only three minor incidents

have been recorded since the understanding in February 2021 with only one incident during 2022," the ministry said.

It said Pakistan continued to retain "proxy war in-frastructure" and that the "functionality" of terrorist training camps, presence of terrorists in "launch pads" and continuing infiltration attempts vindicate that country's "persistent intent". İt said Pakistan continues to exploit the "narco-terror nexus" to radicalise and motivate innocent youth undertake targeting of vulnerable civilians using pistols and grenades.
