# Chaos at Shambhu border Farmers break barricades, tear gas used



### **CHANDIGARH, FAB 13**

The meeting of the farmers leaders with the Central Government Ministers was inconclusive, after which the farmers left for Delhi on Tuesday. Farmers tried to break the

barricade at the Shambhu border, after which the Harvana police fired tear gas shells and a stampede broke out among

The purpose of the Farmers' March to Delhi is to implement the recommendations of the Swaminathan Commission, apart from the legal guarantee of Minimum Support Price (MSP), Pension for farmers and farm workers, waiver

of Farm Loans, police withdrawal of registered cases, relief to Lakhimpuri victims, etc.

The farmers are demanding 'Justice', reinstatement of the Land Acquisition Act 2013, and compensation for the families of farmers killed during the previous Kissan Bills Agi-

The protesting farmers were seen attempting to break the multi-layered barricades using their tractors and hand weapons.

Scenes of chaos filled the Shambhu border as the police tried to stop the protestors

Visuals from the border showed farmers running to-

wards nearby farmland on the sides of the road as police fired tear gas and water cannons to

disperse the protestors. Farmers also faced tear gas shells and water cannons as police tried to stop large groups from entering Haryana through the Khanauri border in Jind district on Tuesday.

Earlier in the day, farmers participating in the 'Delhi Chalo' march to press the Centre to accept their demands, including the enactment of a law guaranteeing minimum support price for crops, faced similar police action at the Shambhu border in Haryana's Am-

demonstrators claimed that a farmer was injured in the tear gas shell firing at the Data Singhwala-Khanauri border. To ensure law and order. Delhi police have al ready enforced Section 144, restricting entry of tractor trolleys and large assemblies. DCP Dwarka Ankit Singh said, "Secc 144 CrPC is imposed in the city, tractor trolleys are not allowed in the city. Social media monitoring has also been done. 

# 2121 km long roads completed during FY 2023-24: ETO

He also expressed confidence that all the remaining road works will also be completed as per the target by March 31 after reviewing the strategy being adopted by the department to complete the remaining 1954 km of road works as per the target fixed for this fi-

The Secretary said that the 2121 km of roads have been constructed so far at a cost of Rs. 1089 crores, and Rs 1066 crore

## VB registers case against patwari, three farmers

The Punjab Vigilance Bureau (VB) has arrested a revenue Patwari and two farmers for availing debt relief of Punjab government amounting to Rs 4,02,222 by submitting wrong affidavits.

Disclosing this here to-day an official spokesperson of the state VB said this case has been registered on the basis of an enquiry against Balkar Singh, Patwari, revenue halqua Hamirgarh, now posted at Tehsil office Bhwanigarh, Sangrur district, a resident of new officer colony, Patiala. Besides this two private persons of village Hamirgarh namely Ram Singh and Surinder Singh have also been arrested and third accused farmer Hardev Singh of Hamirgarh would be arrested soon. Giving more details he added that all the above said farmers duly possess agricultural land more than 5 acres each and were not eligible to get benefits of debt relief provided by the previous government.

These accused, in connivance with the Patwari, have filed false affidavits with the agricultural department for availing the benefits. During the probe it has came to light that the said Patwari had not uploaded actual reports on the portal regarding the lands owned by these farmers and they got illegal debt relief.

It has been found that Ram Singh had received debt relief to the tune of 1,28,249, Surinder Singh got Rs 96,258 and Hardev Singh availed relief of Rs 1,77,716. In this way all the accused have caused loss of Rs 4,02,222 to the state

The spokesperson of Jal Shakti department said here today that a joint action committee was constituted to resolve the doubts and apprehensions regarding rupees six crore Navgaon water supply scheme, under construction at Navgaon Khad in Arki sub-division of Solan district.

He said that few unsocial elements were giving misguiding statements and spreading rumours that the water from the Navgaon rivulet drinking water supply scheme was only for some particular units, which he strongly refuted saying that it was for a population of around 9000 of 71 villages of eight gram panchayats of Solan district which will not cause an adverse effect on the villages downstream falling in bordering Bilaspur district.

He said that on the instructions of the state



government, scientific assessment of water flow was done in Navgaon ravine. He said that after conducting the survey of the source, it was reported that even during the decrease in rainfall, the underground water level of source will remain 380 LPS whereas the demand of water under the scheme was merely 10.53 LPS. As 89 percent of the area under the scheme falls in district Solan, it will not cause any type of water scarcity to the residents or villages falling in Bilaspur district. It was only after the survey it was decided that as scheme

## 50 drums of chemicals removed from perfume factory

**CHANDIGARH, WEDNESDAY, FEBRUARY 14, 2024** 

BADDI: The work of removing flammable chemical waste from the NR Aroma Factory complex located at Jharmajri under the Industrial Town continued for the fourth consecutive day. About 50 drums of chemicals were removed from the factory premises, which were taken to the plant at Dabhota for scientific disposal. Let us tell you that within these four days, around 190 chemical drums have been taken out from the factory, many of which were empty while many of the drums contained chemical which is estimated to be around four thousand litres. The process of removing drums of chemicals has not stopped yet. The effort to remove chemical waste has started again on Tuesday. The surprising thing is that so far around 190 drums of chemicals of 200 liter capacity have been taken out from the NR Aroma factory established in 750 square meter area, in such a situation the question is being raised that there is more than the storage capacity inside the factory premises. A large number of chemicals were stored, but the concerned departments never took notice of it. It is noteworthy that according to the registration done in the Industries Department, it was manufacturing apparel perfumes, whereas according to the State Drug Control Authority, apparel perfume products do not come under the scope of cosmetics and no license is required under the Drugs and Cosmetics Act. Raw materials like Phenyl Ethyl Alcohol, Benzyl Salicylate, Benzyl Benzoate, Iso Propyl Palmitate, Amy Salicylate, Diethyl Phthalate etc. are used in it. DGM Surdashan of Shivalik Solid Waste Management Plant said that the work of removing chemical waste continued on Tuesday also.

The farmer protest has been called by Sanyukt Kisan Morcha and Punjab Kisan Mazdoor Sangharsh Committee led by farmer union leaders Jagjeet Singh Dallewal and Sarwan Singh Pandher.

The farmers have put forth 12 demands before the central government for which they're marching to Delhi.

According to the protesting farmers, the centre promised them better crop prices after which they ended the 2021 protest.

They are demanding to enact a law guaranteeing a minimum support price (MSP) for all crops, as recommended by the Swaminathan Commission report.



# Editorial An ideal teacher

In the outpouring of grief among her students was quite overwhelming. Most little children adore their teachers unconditionally, unlike their seniors who learn to judge as they grow older. But Reethu Sarawgi's influence on her students lasted well into adulthood.

What was the secret of her magical hold on young people? She had a phenomenal memory for names and faces. This, I believe, was not just a gift, it was the result of her concern about each and every child in her care—she was exceptionally kind and generous. Moreover, she pursued each student's individual fortunes through the school years and even after. Since I used to be responsible for the other end of the school, that is the school-leaving years, we often compared notes as to whether a particular child had blossomed the way Reethu had predicted or investigated whether the pushy nursery mother had changed her ways. Parents would have long and deep conversations with Reethu about the finer aspects of parenting, even though they had to hear disturbing statements such as, "There are no bad children — only bad parents."

Reethu's understanding of her young students was evident. Astonishingly, she would spot a Class VIII student and ask colleagues, "Is she still a loner?" Sometimes she would exclaim, "I knew that she would turn out to be a captain — what a little manager she was in the nursery!" Her remarks made me ponder Freud's thoughts on the cruciality of the first five years of life.

Reethu's learning and knowledge made me question the strange belief that many school administrators have that highly qualified people are unsuited for the primary level. "Highly knowledgeable people can't come down to children's level," they proclaim. I strongly believe that you need to have a very fine mind and an abundance of knowledge to deal with small children. They bombard you with questions and often share their worldviews with you, and you had better have the wherewithal (and the patience) to address complex issues in a meaningful way. However, I do agree that teaching little children is not meant for scholarly teachers whose sole goal is to get students to master their coursework and achieve high scores in exams. I admired Reethu's many-faceted mind along with her skills and passions. I loved her sense of humour and ringing laughter. Her interests ranged from literature, films, handicrafts — she excelled at handwork - visual and performing arts to politics, environmental issues and gardening.

She would quote effortlessly from yesteryear poems and have me scurrying to google the relevant context of something she had mentioned. She read not only books on pedagogy but also contemporary novels, poetry, travelogues and essays.

# China "Pushes the Boundaries" with its expanding borders

In late 2021, Chairman Xi Jinping famously told President Joe Biden, "Aggression or hegemony is not in the blood of the Chinese nation. Since the founding of the people's republic, China has never started a single war or conflict, and has never taken one inch of land from other countries." However, such a claim is demonstrably false, as China recklessly pushes forward its boundaries on land and at sea.

Including Bhutan and India, along their shared rugged, mountainous frontier, China is pushing forward wherever it can to forge a fait accompli on the ground. It is doing the same with illegal territorial claims in the South China Sea and attempting the same in Japan's Senkaku Islands.

The Center for Strategic and International Studies (CSIS) in the USA provided an assessment of new People's Liberation Army (PLA) infrastructure near the Indian border. It noted, "China is currently undertaking a major expansion of its infrastructure that is enhancing its ability to project military power along its western frontier" in both Tibet and Xinjiang.

The CSIS report revealed China is constructing or upgrading dozens of airports and heliports, supplemented by new roads, rail and other infrastructure that enhance PLA logistics by permitting greater quantities of troops, weapons and supplies to be shuttled closer to the frontier. It added, "The pace of development in the region accelerated following



standoffs and skirmishes between China and India along disputed portions of their border in 2017 and 2020." The 2017 reference is to the Doklam Plateau, where PLA engineers attempted to build a road. Even more serious was the outbreak of bloody violence at Galwan Valley in Eastern Ladakh in 2020.

In the rugged and unforgiving high-altitude terrain of Tibet and Xinjiang, airports and heliports grow exponentially in importance. They are vital for moving personnel and equipment into the area, plus they serve as launch pads for reconnaissance assets and potentially strike missions.

CSIS assessed: "The airpower buildup taking place on China's western frontier is sweeping in scale.

Based on analysis of satellite imagery and other open-source material, China Power has identified 37 airports and heliports within Tibet and Xinjiang that have been newly constructed or upgraded since 2017 ... At least 22 of these are identifiable as military or dual-use facilities, or are expected to be once they are completed. The pace of this activity sped up significantly in 2020. That year alone, China began constructing seven new air facilities and initiated upgrades at seven others."

Much of the construction is occurring in Tibet. All five existing dual-use airports have received new terminals, hangars, aprons and runways since 2017, while four new airports have been constructed less than 60km from the Indian border.

For example, Lhuntse, Ngari-Burang and Shigatse Tingri Airports fill glaring gaps in the PLA's coverage. The dual-use Shigatse Peace Airport is the closest to Doklam, and it has received a large underground facility that has at least three entrances.

CSIS added: "The PLA is also significantly scaling up its ability to conduct helicopter-based operations through the construction of at least five new heliports in Tibet, and the upgrading of two heliports. These heliports, which are operated by PLA Army aviation units, are dotted throughout Tibet, stretching from Rutog County in the west to Nyingchi City in the east. The addition of these heliports stands to significantly enhance PLA operations in the mountainous region, since helicopters are capable of manoeuvring in ways that aeroplanes and ground equipment cannot.'

As for Xinjiang, at least 15 airports have been upgraded since 2017, seven of which are military or dual-use. One example is Hotan, 240km from the Indian border. It has a new runway, additional tarmacked areas and an expanded air defense complex.

Three new airports have started

construction in Xinjiang since 2019, including Tashkorgan near the border junction with Pakistan, Afghanistan and Tajikistan.

Nonetheless CSIS explained:

Nonetheless, CSIS explained: "Despite the military benefits that China's investments in the region have brought, the PLA faces several

notable disadvantages compared to India. Much of China's side of the border is situated on the highest portions of the Tibetan Plateau, which is often described as the 'roof of the world', owing to its high elevation. Twenty of China's airports and heliports within Xinjiang and Tibet are located more than 3,000m above sea lovel."

Such altitudes present massive operational challenges for the PLA. Thin air affects the performance of aircraft taking off, which in turn requires longer runways and aircraft may not be able to carry full weapon, cargo or fuel loads. Cold and harsh weather adds its own challenges too.

Official Chinese figures reveal that Tibet's highway system grew 51 per cent from 2015-20 to a total of 11,820km. In the same period, Xinjiang's highway network grew from 17,830km to 20,920km. As well as enhancing economic development, these roads assist the PLA in moving supplies. For instance, at least eight roads stretching from the G219 highway towards the Indian border are being constructed. The PLA would be able to use them to quickly reposition troops if another Galwan Valley confrontation occurred, for example. Completed in 2021 and reducing travel time by eight hours, another new road connects Nyingchi to Medog County in eastern Tibet. # How fatty acids plays key role in creating memories



Researchers at the University of Queensland have demonstrated the vital role that saturated fatty acids play in the brain's storage of memories.

A new cure for neurodegenerative illnesses may now be possible, thanks to research conducted by Dr Isaac Akefe of the Queensland Brain Institute at the University of Queensland. He has also discovered the genes that underlie the process of memory creation.

The findings were published in the EMBO Journal.

"We've shown previously that levels of saturated fatty acids increase in the brain during neuronal communication, but we didn't know what was causing these changes," Dr Akefe said.

"Now for the first time, we've identified alterations in the brain's fatty acid landscape when the neurons encode a memory.

"An enzyme called Phospholipase A1 (PLA1) interacts with another protein at the synapse called STXBP1 to form saturated fatty acids."

The brain is the body's fattiest organ, with fatty compounds called lipids making up 60 per cent of its weight. Fatty acids are the building blocks of a class of lipids called phospholipids.

The work done in Professor Frederic

The work done in Professor Frederic Meunier's laboratory has shown that STXBP1 controls the targeting of the PLA1 enzyme, coordinating the release of fatty acids and directing communication at the synapses in the brain. "Human mutations in the PLA1 and STXBP1 genes reduce free fatty acid levels and promote neurological disorders," Professor Meunier said. "To determine the importance of free fatty acids in memory formation, we used mouse models where the PLA1 gene was removed.

# Does physical activity reduce pain intensity in cancer survivors?



People who have had cancer frequently feel persistent pain, but a new study suggests that staying physically active may help reduce its intensity.

The study is published by Wiley online in CANCER, a peer-reviewed journal of the American Cancer Society.

Although physical activity has been shown to lessen various types of pain, its effects on cancer-related pain are unclear. To investigate, a team led by senior author Erika Rees-Punia, PhD, MPH, of the American Cancer Society, and first author Christopher T.V. Swain, PhD, of the University of Melbourne, in Australia, analyzed information pertaining to 51,439 adults without a history of cancer and 10,651 adults with a past cancer diagnosis. Participants were asked, "How would you rate your pain on average," with

responses ranging from 0 (no pain) to 10 (worst pain imaginable). Participants were also asked about their usual physical activi-


U.S. guidelines recommend 150 minutes (2 hours 30 minutes) to 300 minutes (5 hours) a week of moderate-intensity, or 75 minutes (1 hour 15 minutes) to 150 minutes (2 hours 30 minutes) a week of vigorous-intensity aerobic physical activity. Based on participants' responses, the investigators found that, for individuals who had cancer in the past as well as for those without a history of cancer, more physical activity was linked with lower pain intensity. The extent of the association was similar for both groups of individuals, indicating that exercise may reduce cancer-related pain just as it does for other types of pain that have been studied in the past.




